

# EVISA FOR ZAMBIA

Government of Zambia has launched e-Visa portal allowing short-term visitors to get a visa in effortless way.

You must be able to present all the required documents at Zambia state border

- Travel Document/Passport
- Document proving purpose of travel
- Proof of accommodation
- Return / Onward Air ticket
- Yellow Fever Vaccination Certificate

Requirement for all visas - applicant is required to enter Zambia within 90 (ninety) days since the Date of Approval of his/her application (this date will be specified in the Visa Authorisation Letter to be emailed to the applicant's email address specified later in the Application Form).

## ORDINARY VISAS

- Single entry - applicant can stay in Zambia for the period of 90 (ninety) days during a given calendar year passed since the date of entry into Zambia.
- Double entry - applicant can visit Zambia up to 2 (two) times during 90 (ninety) days calculated since the date of the first entry into the country. Total number of days spent in Zambia should not exceed 90 (ninety) days.
- Multiple entry - applicant can visit Zambia unlimited number of times during 90 (ninety) days calculated since the date of the first entry into the country. Total number of days spent in Zambia should not exceed 90 (ninety) days.

## BUSINESS VISAS

- Single entry - applicant can stay in Zambia for the period of 30 (thirty) days during a given calendar year passed since the date of entry into Zambia.
- Double entry - applicant can visit Zambia up to 2 (two) times during 30 (thirty) days calculated since the date of the first entry into the country. Total number of days spent in Zambia should not exceed 30 (thirty) days.
- Multiple entry - applicant can visit Zambia unlimited number of times during 30 (thirty) days calculated since the date of the first entry into the country. Total number of days spent in Zambia should not exceed 30 (thirty) days.

## TRANSIT VISAS

- Transit visas are issued to nationals who require visas to enter Zambia and are transiting through using land transport and shall be valid for a maximum period of 7 (seven) days. Number of visits to Zambia during this 7 (seven) days period is unlimited.

## DAY TRIPPER VISAS

- A Day Tripper visa shall be issued at a port of entry to a tourist who visits Zambia for less than 24 hours and makes exit through the same port. Except those nationals that fall under referred visa.

### For **Business/Conference Visa:**

1. Coloured copy of Bio data Pages of Valid passport
2. Good Quality Photos in Jpeg
3. One page visa request letter from Applicant or Employer addressed to Director General of Migration, Zambia
4. One page invitation letter from host in Zambia addressed to Director General of Immigration, Zambia
5. Copy of Certificate of Incorporation of Company in Zambia

### For **Tourist Visa:**

1. Coloured copy of Bio data Pages of Valid passport
2. Good Quality Photo in Jpeg
3. Hotel Accommodation
4. Air ticket or Travel Itinerary
5. Details of Employment of Applicant
6. One page visa request letter from applicant addressed to Director General of Immigration, Zambia

### For **Visa for Visiting Family/ Friend :**

1. Coloured copy of Bio data Pages of Valid passport
2. Good Quality Photo in Jpeg
3. One page letter of Invitation having name, contact details and email id of inviter addressed to Director General of Immigration, Zambia
4. Copy of Passport, Residence permit of Host in Zambia
5. Air ticket or Travel Itinerary
6. Details of Employment of Applicant
7. One page visa request letter from applicant addressed to Director General of Immigration, Zambia

### For **Visa for Study Purpose : Single Entry Only**

1. Coloured copy of Bio data Pages of Valid passport
2. Good Quality Photo in Jpeg
3. Acceptance letter from Educational Institute in Zambia
4. Proof of accommodation in Zambia
5. Air ticket or Travel Itinerary
6. Visa request letter from applicant addressed to Director General of Immigration, Zambia
