## Meet the Candidates Event

Topic 1 Please tell the voters a little about yourself and what makes you a good candidate to help perform the crucial work of establishing Spring Lake.

## Response

Good evening, I am Robert Marsh. I have loved living in Spring Lake for the past 31 years. Spring Lake has been the best place on earth to live and raise a family. I believe I can contribute to this new town because of my experience working with the public almost every day. I have owned a used car dealership in Payson for the past 21 years. Being a successful business owner has helped me tremendously in the area of building trust and helping those in need of a vehicle. I understand the importance of revenue. I also know how absolutely critical it is to keep expenses where they should be. A major contributor to my success has been maintaining the highest level of integrity and using a common sense approach to all that comes along. When I first opened my business it was very eye opening with all the ordinances that I had to deal with. I had opened 4 other dealerships in 2 different states and never experienced the ordinances and city requirements like I did in Payson. ## Response

When I moved here 31 years ago, I was so happy to be back in the country and the small community atmosphere. One of my visions of Spring Lake moving forward would have it be the most welcoming and inviting place that anyone could ever live. As changes take place in the future, we will have new people move here. My neighbor Richard Lovell, just to the west of me, passed away recently. Whoever moves into his place hopefully will feel welcomed. We will have a **limited number** of new homes built in the coming years. I mentioned in my previous response the dislike for high density housing. I am completely against this in our new town. I do believe that any new homes that are to be built should be done in a thoughtful and fair manner. Planning and zoning will be paramount to limit any large scale developments. To maintain our township and not become a city, we need to keep our population under 1,000 residents. There needs to be some growth because the revenue that is needed to run a municipal township will increase as time passes. If nothing changes and we stay **exactly** the same, all of our property taxes will increase beyond what is acceptable and normal. The majority of revenue comes from the land owners and any businesses that generate sales tax. Although I don't see Spring Lake attracting big box retailers nor most retail type businesses, there are some types of business that could find this an attractive place to open up shop.

Some examples could be a nursery or a bed and breakfast, both of which generate sales tax. Having more land owners will increase the revenue needed to run our town. I feel strongly that those in our town whose land is used for agriculture should have ordinances that protect that use. So I do envision a lot of input from our citizens to come up with a viable way to keep a small town small, but expand the revenue base with limited new houses being built and some new businesses. I could talk about the amazing dreams that everyone living here might have and what living in the town of Spring Lake would be like. I could say "Hey, elect me and you'll all get a big fat check in the mail and have everything you want in life. Our town will have a walking trail with a covered bridge over Spring Lake that lights up at night, as well as a rec center and air conditioned covered parking for the future community buildings." But that would make me a true politician and I'm definitely not one of those. The fact of the matter is this. I do have a vision of super good people making very important decisions that will ultimately impact each one of us. Whoever those individuals are, they need to be good at listening to those who voice their opinions and concerns. Our elected leaders should do what the majority of residents want and not implement any personal ambitions. If our citizens don't voice their personal opinions then our leaders are left to do what they believe is best. I am a good listener and always use a
