New applicants will be required to have a current NWMCF member of good standing as a sponsor. There will be a 90 day probation period. After 90 days, the sponsor will present the Board with a review of the probation period. The Board will then either approve or deny the applicant. If the applicant is denied, a full refund of the dues will be issued. The conditions of the probation period will require the applicant to:

Show up for at least one club function within the 90 day probation period. Examples include: NWMCF monthly club meeting, a club-sponsored event, garage day, etc.

If the applicant is unable to participate, the sponsor will be required to present a case on why the applicant should be considered for an exception to these conditions.

If the applicant applies for membership without sponsorship, one of the Board members will be appointed by the President to take on the responsibilities of welcoming them to the club and get to know them as their sponsor.

If the applicant elects to leave the club within the 90 probation period, a full refund will be issued minus setup fees (i.e. initiation fee, additional nametags, clings).
