Environmental Caucus Urges Emerson Point Purchase by County

The **Manatee Democratic Environmental Caucus** is urging all residents of Manatee County to contact the members of the Board of County Commissioners (BOCC) and insist that the Emerson Point Expansion purchase go forward.

The BOCC is expected to put the Emerson Point Expansion purchase on its March 12 agenda. You can contact individual BOCC members by calling 941-745-3700 or visiting the county website for email addresses **here**.

A 97-acre parcel on Terra Ceia Bay's southern edge is adjacent to Emerson Point Preserve, which is on the extreme west portion of Snead Island. The land was purchased by the state in the 1990s and leased to Manatee County. It is designated by the state as an Outstanding Florida Waters area.

"It is time for the BOCC to put the purchase of the Emerson Point Expansion on the agenda and to approve it," said Ruth Lawler of the Democratic Environmental Caucus in an email announcement. "Don't let this unique opportunity slip through your fingers."

Manatee County's Environmental Lands Management and Acquisition Committee (ELMAC) recommended purchase of the Emerson Point extension to the county commissioners in April of 2023. BOCC voted unanimously to move forward on the purchase in the same month. In December, the BOCC received an update on the status of Emerson Point.

At a recent BOCC meeting there were multiple citizen comments supporting the Emerson Point Expansion purchase.

Former County Commissioner and current publisher of *The Bradenton Times*, Joseph McClash, implored the BOCC to bring the matter to a vote because it has been a year since the commissioners' vote to approve. He also said the land will go to a developer if the county doesn't purchase it.

Executive Director of Suncoast Waterkeepers, Abbey Tyrna, asked the Board to put the Emerson Point expansion on the agenda and then to approve it.

Commissioner George Kruse stated that the April 2023 vote on Emerson Point was not to approve the purchase but to explore the acquisition. He further said county staff is negotiating the purchase price.

Commissioner Kevin Van Ostenbridge agreed with Kruse on the matter and said the challenge now is "the exorbitant price" set by the sellers. So far there has not been a funding commitment by the state, according to Van Ostenbridge.

Kruse expressed concern that the Board would "kick this down the road" as it has in the past. He made a motion to direct staff to come up with a last, best offer and add this topic to the agenda for the next meeting (March 12). The motion passed 5-2.

Read On Manatee! Opposes Library Book Removals

ReadOnManatee! has emerged as a powerful voice opposing actions on the part of a few citizens, politicians and school board members to remove what they deem are objectionable books from school libraries.

To date, at least 74 books have been removed from Manatee school libraries for content that refers to race history or LGBTQ identity.

The latest addition to the removed books list includes the New York Times bestseller, *The Freedom Writers Diary*.

In her February 27 address to the Manatee School Board, Marie Masferrer, who leads ReadOnManatee!, explained: "This is a powerful collection of journal entries from high school students who overcame adversity through the transformative power of education. Their inspiring stories demonstrate the importance of empathy and the potential for positive change."

Even though Masferrer was refuting a request for removal made by one citizen, the application for removal now gets consideration by the school board.

Chantal Wilford, who ran unsuccessfully in the last school board election for the second district, said that she had learned "the objection to [Freedom Writers] was that the book promotes gang violence and drugs as a couple of the student authors were experiencing this in their home life and wrote about it."

Masferrer maintains that these books actually reflect the problems that modern students face and so deserve to be the subject of reading and discussion in school and public arenas.

Citizen-Scientists Step Up for Manatee's Environment

Manatee has seen its county government cave to the will of developers who convince county commissioners to gut wetlands protections. The corruption of our BOCC will exact a price on the health of the water, plant and animal life in Manatee.

In this current climate, citizen-scientist projects are emerging in Manatee, signaling what Ruth Lawler, of the Manatee Democratic Environmental Caucus, deems is a ripe moment to step up for the environment.

Lawler, an iconic figure in Manatee's environmental movement, regularly attends BOCC meetings, attempting to educate commissioners on the value of wetland protections. She hosts speakers addressing a range of citizen-scientist projects including restoring oyster populations, monitoring fisheries and reviving neighborhood ponds.

Working alongside Lawler is **Suncoast Waterkeeper** Executive Director Dr. Abbey Tyrna, who provides scientific data documenting the health of Manatee area waterways. Dr. Tyrna has recruited groups of citizen-scientists as Mangrove Rangers. The Rangers patrol vulnerable stands of mangroves using drones to capture aerial photographs of the health of these shoreline groves. Working in teams, one member operates a boat, another a drone, while two others spot and record the team's findings.

The data these teams yield will be useful to Suncoast Waterkeeper in providing visual evidence and data of the decline of the mangroves' health. The organization has been at the forefront of the public fight to provide factual evidence to the BOCC in their deliberations over re-writing sections of the county's Comprehensive Plan to favor shrinking wetland buffers.

Another citizen-scientist effort that uses the aerial perspective of drones detects threats to manatees. This project is led by Mote Aquarium's Dr. Beth Brady, who directs volunteer drone operators to count the number of manatees in a specific area. The pictures the drones collect also reveal the physical condition of the manatees - body mass and scars that indicate boat trauma. These photos help Dr. Brady identify which animals need rescue.

Nicholas Azzara, spokesman for <u>Keep Manatee Beautiful</u>, says that the group must rely on a variety of ways of reaching out to potential volunteers, utilizing media sources, newsletters and social media. The key, according to Azzara, is to be repetitive about the group's message and the purpose of its events.

Under the directorship of Jennifer Hoffman, Keep Manatee Beautiful has been successful in bringing together volunteers, businesses and local governments to provide solutions to littering, illegal dumping, solid waste disposal, recycling and maintaining the beauty of Manatee County.

Such projects, fueled by the energy and passion of both new and experienced volunteers, are the eyes and ears of Manatee's environmental health. Volunteers have emerged despite the indifference of county government toward environmental protections. 


