

# Manatee Petitions Carry Abortion Amendment Over First Hurdle

The campaign to put abortion on the ballot has passed an essential milestone due to the tireless work of volunteers from the Manatee County Democratic Party and other local organizations.

The Florida Division of Elections (DOE) announced that as of Jan. 5 it had 910,946

verified petitions in support of letting the voters decide on a constitutional amendment to limit government interference with abortion. That was 19,376 signatures above the required 891,523 valid petitions.

In addition to a statewide requirement, 14 of the 28 congressional districts in Florida also had to collect a set number of petition signatures based on the number of local voters in the last general election. The goal for the 16th Congressional District, made up of all of Manatee County and part of Hillsborough County, was 32,935 valid signatures. As of Jan. 5, the DOE reported 35,618 valid petitions came from the 16th District. Seventeen congressional districts across the state had met their assigned goal.

"The Manatee County Democratic Party was an essential player in the local campaign," said MCDP Chair Chris Wetherington. "We were on the ground from the beginning, serving as a regional hub for collecting petitions, and we'll continue the fight through the November election. This amendment is key to securing every woman's right to reproductive healthcare freedom."

While the news is positive, the campaign to get the amendment on the November ballot still faces potential roadblocks. The Florida Supreme Court must rule on the ballot amendment language. Oral arguments are scheduled for Feb. 7. Furthermore, Attorney General Ashley Moody has vowed to fight the amendment from appearing on the ballot.

If the Supreme Court approves the initiative, the hardest battle will be next November. Sixty percent of Florida voters must approve the amendment for it to become law.
