

Take A Stand Against Gun Violence in Manatee

Manatee County residents are poised to protest a potential escalation of gun violence by demonstrating against a proposal that would arm county employees during working hours.



Manatee County's commissioners are scheduled to consider Commissioner James Satcher's proposal allowing county employees to carry firearms while working. The topic is on the agenda for the Tuesday, July 26 meeting.

"This is yet another stupid move by James Satcher. Once again, he fails to represent his community in favor of a personal extremist position that endangers residents and wastes taxpayer money," said Manatee County Democratic Party Chair Tracy Pratt.

"An overwhelming majority of Americans support common-sense gun policy, including the majority of gun owners," Pratt continued. "This attempt to arm county employees will result in unnecessary deaths and injuries and may subject the county to expensive lawsuits and insurance premiums."

County residents against the proposal will peacefully demonstrate on July 26 from 8 to 9 a.m. outside the Manatee County Administration building, 1112 Manatee Ave West, Bradenton. Demonstrators are encouraged to wear a red shirt. The organization, Moms Demand Action, will distribute red shirts at the

demonstration.

Manatee Democrats join with other organizations to urge residents to contact the County Commissioners and demand they reject Satcher's proposal. Commissioners' email addresses are available <u>here</u>. Residents may submit a written comment into the public record for an upcoming meeting <u>here</u>. Writing an opinion column in Sarasota's Herald-Tribune, Ginger McCallum and Carol Rescigno said, "This is a dangerous idea that would irreparably harm Manatee County, its employees, its citizens and its reputation. If adopted, this policy would create a hostile workplace fraught with the threat of accidental or intentional injury or death from gun violence."

McCallum is the local volunteer lead for Moms Demand Action Manasota. Rescigno is the president of Brady United Against Gun Violence, Sarasota.

Gun violence in America is a public safety issue and a public health disaster. Some statistics that demonstrate the magnitude of the crisis:

- More than 110 people are killed with guns and 200 are shot and wounded daily in the U.S.
- Each year, 40,000 people die and 73,000 suffer injuries from gun violence.
- Florida has the 27th-highest rate of gun deaths in the country at more than 2,800 each year.
- A Stanford University study found a 13 to 15 percent increase in violent crime in states that approved right-to-carry concealed handgun laws.

Freedom Starts Here is more than a catchy slogan. It's a call to action.

If you are among the many voters who want to see a change in direction for Manatee County, the state and nation, be prepared to vote in the August 23 elections for school board and party primaries.

Your vote could very well determine who will be seated on our county school board.

School board candidates are not officially identified by political party. A candidate needs to receive "50 percent plus one" of the votes to retain or gain a seat on the school board. If no candidate reaches that threshold in the August election, the top two vote getters move to the general election in November.

These registered Democrats are running in the non-partisan school board elections:

- · District 2: Harold Byrd
- · District 5: Current School Board Chair James Golden
- District 5: Chantal Wilford

Locally, there are primary races for county commission and city positions. There are also primary races for state and national legislative seats, a race for U.S. senator and the governor's race. There are no such things as wasted votes or canceled out votes because all votes count.

Vote from Home. If you are enrolled in the county's Vote By Mail system, watch the mail this week for your ballot. The office of the Supervisor of Elections (SOE) began mailing ballots on July 14. Complete your ballot according to the instructions. Mail your ballot to the SOE so it is received before Election Day, August 23, at 7 p.m. You will be able to track receipt of your ballot online. **Enroll in Vote By Mail** on the SOE website, Or call (941) 741-3823.

Vote Early Aug. 13 to Aug. 20 Go to any Manatee County Early Voting site from 8:30 a.m. to 6 p.m. You can vote in person or drop off your mailed ballot in the secure box outside the polls. <u>See location</u> <u>details</u>.

Election Day Aug. 23. Go to your voting precinct location, 7 a.m. to 7 p.m. Find your voting precinct and sample ballot <u>here</u>. Be sure to check on your voting location, as some have changed.


