2022 Gala: A Democratic Night to Remember



By William Clapper – The Manatee County Democratic Gala was certainly a night to remember.

A sellout crowd of 320 Democrats cheered as three of the gubernatorial candidates gave solid reasons why the current governor must be voted out of office. Former governor Congressman Charlie Crist, current Commissioner of Agriculture Nikki Fried and state Senator Annette Taddeo shared personal stories and each gave rock solid reasons why they should be the next governor of Florida.

Two local awards were presented during the ceremonies. Michelle Grimsley, chair of the Manatee County Democratic Black Caucus accepted the Bill McGrath Memorial Award on behalf of the MCDBC for its efforts to register voters and promote vote-by-mail. Graciela Greenberg, former chair of the Manatee County Democratic Hispanic Caucus, accepted the John Lewis Memorial Award for her lifetime dedicated to community and democratic values. The Lewis Award commemorates the legacy and contributions of Congressman John Lewis of Georgia, who fought for civil rights and the elimination of racial segregation.

Manatee County Democratic Party chair Tracy Pratt gave the assembly a glimpse of the party's accomplishments the past year and prepared county Democrats for the battles ahead.

"With right-wing attacks on our school boards and overt corruption on our county commission, we know we must remain vigilant and fight for our Democratic values at all levels of government," said Pratt.

County Seeks Democratic Poll Workers

The Manatee County Supervisor of Elections is looking for Democrats to serve as poll workers for the primary election this August. The SOE strives to have an even split of Democratic and Republican poll workers.

Poll workers staff polling places and the number of available poll workers could impact how many polling places are open on election day. There are five paid positions at each polling place: Certified Clerk, Certified Assistant Clerk, Certified Tabulator Inspector, Certified EPB Ballot Inspector and Election Deputy.

Registering new voters is not enough to ensure that they actually vote. Recently registered voters need contact from like-minded voters to provide encouragement and comfort to build confidence and pride in the voting process.

The Follow-up Call Team is an initiative Indivisible Manatee developed to provide support to the voters who register during neighborhood canvassing efforts. A volunteer will call the voter after their registration becomes official.

The newly registered voter will be congratulated and asked if they got their Voter ID Card. Closer to the elections, calls will be made to ensure each voter received a mail ballot, answer questions they may have and let them know which candidates and measures Democrats support.

Blue Wave Voter Outreach May 15

Manatee County's Blue Wave Coalition's monthly voter outreach event is Sunday, May 15 at 3 p.m. with drinks and snacks provided. A voter enrolled in VBM is two times more likely to vote than one who is not enrolled.

S.T.R.E.A.M. Sponsors a Joshua Assembly




