Take Action Meeting Stressed Resident Involvement



During the Take Action event last month at the Palmetto Library more than 80 people heard from the candidates for local offices and the Manatee County Democratic Party (MCDP) executives about how to become involved and make a difference in our community this election year.

"Our goal was to recruit volunteers and provide opportunities to meet candidates," said Tim Eiseler, District 3 Team leader. "It's very important to engage and educate new participants in the Democratic process who may not have been involved before."

Eiseler reported that attendees found the Take Action meeting helpful in finding out which precinct they live in, who their candidates are and their positions on local issues and what volunteers can do to take action and boost voter turnout.

"Now that potential volunteers have come to meetings and received information, the challenge is to get them to commit to a specific task of their interest to develop a much broader base of volunteer support, importantly to include long term positions as precinct captains," said Eiseler. "The district

coordinators and precinct captains will be following up with attendees to secure their ongoing involvement."



Eiseler offered a special thank you to the District 3 Team who organized and planned the event. He also thanked the MCDP data and communications teams.

Democratic candidates present at the meeting included: Diana Shoemaker, candidate, District 3, Manatee County commissioner; Sari Lindroos-Valimaki, candidate, District 7, at large, Manatee County commissioner; Glenn Pearson, candidate District 1, Manatee County commissioner; and Jan Schneider, candidate, U.S. House of Representatives, District 16.

Holmes Beach Mayor Judy Titsworth spoke about the current erosion of home rule for Anna Marie Island. Pam Coachman, Bradenton city councilwoman for Ward 5, Sheldon Jones, Palmetto city commissioner, and Heather Felton, school board candidate for District 1, were also present.

Districts 4 and 5 Dems Urge Neighborhood Participation

The brand-new Lakewood Ranch Library was the site for the April meeting of District 4 and 5 Manatee Democrats, Saturday, April 27.

District 4 encompasses the extreme southern portion of Manatee County while District 5 is the eastern part of the county.

Led by Rob Usher, the meeting focused on neighborhood networking and the ongoing effort to recruit more precinct volunteers. Precinct volunteers play an important role in developing a neighborhood Democratic presence. This effort provides information and support to Democratic voters and helps in Get-Out-the-Vote (GOTV) activities in election years.

Usher discussed the need to encourage Democratic voters to re-enroll in the Vote-By-Mail program every election year. Receiving your ballot and voting by mail is convenient and safe as it gives voters the comfort of voting from home. It's important for voters to fill out their ballot carefully and to make sure their signature matches what is on file with the Supervisor of Election (SOE) office. Acknowledging that Michael Bennett, long time Supervisor of the Board of Elections

for Manatee, has been replaced by the gubernatorial appointment of former County Commissioner, James Satcher, Usher warned that Satcher is not only highly partisan, but also highly inexperienced in running an election. This appointment of an inexperienced and partisan person has generated concern amongst citizens and political leaders alike.

The changes within the SOE administration have prompted the Manatee County Democratic Party to inform all voters of the need to verify their voter registration and Vote-By-Mail status. Manatee Democratic leaders expect signature challenges for early and mail-in voters.

The meeting was an example of a textbook precinct call for grassroots participation. A lengthy Q and A session outlined the process to recruit, inform and expand party participation.


