#### **Manatee DEC Elects Slate of Officers**

The Democratic Executive Committee (DEC) of the Manatee County Democratic Party elected Brett Thomas chair at its monthly meeting, January 28.



Thomas will lead the county party with the help of the other elected officers – Randi Sathan, vice chair; Randy Cooper, treasurer; and Kathryn Brightbill, secretary. Thomas commented on what he believes the party needs to be successful.

"Our priority must be to rebuild the organizing infrastructure in the neighborhoods and precincts," he said. "I'd like to have meetings by district and gather all the precinct captains together."

Other areas of concern, according to Thomas, are: robust fundraising efforts, increase the size and diversity of the DEC, use all the social media resources available to attract younger voters and a sustained effort to focus on close to the people issues such as flooding, insurance and traffic.

### Enroll in Vote-By-Mail Program for 2026 Election

Voting by mail has gained popularity because it is a safe and convenient way to cast your ballot. For many years, Manatee County voters who have voted by mail have become accustomed to automatically receiving a ballot in the mail. However, that process was changed by the state legislature.

Florida voters are now required to make a new request to receive a Vote-By-Mail (VBM) ballot for every election cycle, including 2026.

Make your VBM request by visiting www.votemantee.gov/VBM or by calling the Supervisor of Elections at 941-741-3823 and pressing 1.


