“Initial data falsely suggested that the infection fatality rate was up to 2-3%. But emerging data showed that the median infection fatality rate is 0.23%. Emerging data has shown a staggering amount of so-called ‘collateral damage’ due to the lockdowns. This can be predicted to adversely affect many millions of people globally with food insecurity [82-132 million more people], severe poverty [70 million more people], maternal and under age-5 mortality from interrupted healthcare [1.7 million more people], infectious diseases deaths from interrupted services [millions of people with Tuberculosis, Malaria, and HIV], school closures for children [affecting children’s future earning potential and lifespan], interrupted vaccination campaigns for millions of children, and intimate partner violence for millions of women. In high-income countries, the collateral damage has also been staggering, affecting visits to emergency departments and primary care for acute (e.g., myocardial infarction, stroke) and ‘non-urgent’ (‘elective’ surgery, and cancer diagnosis and treatment) conditions, intimate partner violence, deaths of despair, and mental health. Of excess deaths occurring during the pandemic in high-income countries, 20-50% are not due to COVID-19. There was an unexplained 83% increase of 10,000 excess deaths from dementia in England/Wales in April, attributed to lack of social contact causing a deterioration in health and wellbeing of these patients.”

“It was established in the first few months of the Covid-19 pandemic that the infection mortality risk varied by more than 1,000-fold across the age span, and that people without chronic health conditions such as diabetes, obesity, heart disease, kidney disease, cancer history etc., were at negligible risk of mortality and very low risk of hospitalization. At that point, it was straightforward to define categories of high-risk individuals who on average would benefit from public health interventions, vs low-risk individuals who would successfully weather the infection without appreciable or long-term issues. Thus, an obsessive, one-size-fits-all pandemic management scheme that did not distinguish risk categories was unreasonable and oppressive from the outset. Accordingly, measures promoted by plausibility to reduce infection transmission, even had they been effective for that purpose, have not served good pandemic management. These measures however were never justified by scientific evidence in the first place. ...The negative consequences of large-scale quarantine are so extreme (forced confinement of sick people with the well; complete restriction of movement of large populations; difficulty in getting critical supplies, medicines, and food to people inside the quarantine zone) that this mitigation measure should be eliminated from serious consideration.”

## SUMMARY OF KEY COVID FACTS

These summary points have been proven by thousands of studies conducted by tens of thousands of doctors and medical scientists.

- ▶ Medically and scientifically, Covid-19 is a Severe Acute Respiratory Syndrome (SARS) Coronavirus 2, and is named (SARS-CoV-2). There are several SARS viruses, and these have been around for many, many years.
- ▶ The actual overall fatality rate of covid - averaged across all ages - is 0.1 - 0.3%. It is lower for people under 60, and higher for people over 60.

- ▶ Children are remarkably immune to covid illness and death. 7X more children die from flus than from covid.
- ▶ Dr. Michael Yeadon points out that the "novel" covid-19 contagion is novel only in the sense that it is a new type of coronavirus: *"There are at least four well characterized family members (229E, NL63, OC43 and HKU1) which are endemic and cause some of the common colds we experience, especially in winter. They all have striking sequence similarity to the new coronavirus."* So, covid-19 is in the same family of viruses as the common cold and flu, even if it is slightly more lethal.
- ▶ Dr. Michael Yeadon: *"It is now established that at least 30% of our population already had immunological recognition of this new virus, before it even arrived...COVID-19 is new, but coronaviruses are not. A major component our immune systems is the group of white blood cells called T-cells whose job it is to memorise a short piece of whatever virus we were infected with so the right cell types can multiply rapidly and protect us if we get a related infection. Responses to COVID-19 have been shown in dozens of blood samples taken from donors before the new virus arrived."*
- ▶ PANDA (Pandemic Data & Analytic): *"SARS-CoV-2 presents a negligible risk to the great majority of the world's population. It primarily poses a risk to elderly, metabolically unhealthy and immunocompromised individuals. Many individuals already had a degree of immunity acquired through previous encounters with similar viruses. Moreover, those infected develop further natural immunity against severe disease, which appears to be more flexible and durable than any protection acquired through the Covid-19 vaccination."*
- ▶ Covid is easily treatable at the early stages. 80-85% of covid deaths COULD HAVE BEEN PREVENTED. This means millions of covid deaths worldwide were needless.
  - Dr. Peter McCullough: *"COVID-19, no matter what variant, is easily treatable at home. About 85% of hospitalizations and deaths are completely avoidable with early treatment."*
  - Dr. Theresa Lawrie: *"This medicine prevents deaths by 80%. So 80% of those people who are dying today don't need to die because there's ivermectin."*

- ▶ Asymptomatic people should not get tested. Natural immunity is robust, complete and durable. *"The virus is not spread asymptotically. Only sick people give it to other people."* - Dr. Peter McCullough
- ▶ Numerous studies have proven that natural immunity is superior to any covid vaccine.
- ▶ Treating covid-19, no matter what variant, is easily treatable at home. For people at high risk or high exposure, early or prophylactic treatment is essential to prevent progression of the disease. According to hundreds of studies, early outpatient treatment of covid significantly reduces hospitalizations and deaths.
- ▶ Age profile: The median age of covid deaths is over 80 years in most Western countries (78 in the US) and about 5% of the deceased had no serious preconditions. The age and risk profile of covid mortality is therefore comparable to normal mortality, but increases it proportionally.
- ▶ Nursing homes: In many Western countries, about 50% of all covid deaths have occurred in nursing homes, which require targeted and humane protection. In some cases, care home residents died not from the coronavirus, but from weeks of stress and isolation.
- ▶ Excess mortality: Overall, the pandemic has increased mortality by 5% to 25% in most Western countries. The majority of additional deaths have NOT been caused by covid, but by government restrictions and lockdowns, as well as an aging population.
- ▶ Symptoms: 85-90% of all infected persons show no symptoms. Overall, about 90% of symptomatic people develop at most mild or moderate symptoms and do not require hospitalization. Early outpatient treatment significantly reduces hospitalizations.
- ▶ Much has been written in the news media and spoken by politicians about the dangers of overcrowded hospitals because of covid-19. There have been many reports of many hospitals swamped with covid patients. Over 90% of these reports are either completely false, or exaggerated. Very few hospitals were overrun with covid at any point over the past 2 years. Those few that were, were overloaded for a short time. The truth is that 98% of all hospitals in the world experienced NO increases over previous years, and NO hospital was ever full or overloaded with only covid patients.
- ▶ Masks: There is still little-to-no scientific evidence for the effectiveness of face masks in the general population, and the introduction of mandatory masks couldn't contain or slow the epidemic in most countries. If used improperly, masks actually increase the risk of infection.
- ▶ Children and schools: In contrast to influenza, the risk of disease and transmission in children is rather low in the case of covid. There was and is therefore no medical reason for the closure of elementary schools or other measures specifically aimed at children.
- ▶ Testing. The PCR test produce 50-95% false positives, depending on how many amplification cycles are run. In this regard, the so-called cycle threshold or ct value is an important parameter.

- ▶ Virus mutations: Similar to influenza viruses, mutations occur frequently in coronaviruses. Most of these mutations are insignificant, but some of them may increase the transmissibility of the virus.
