SUMMARY OF KEY COVID FACTS

These summary points have been proven by thousands of studies conducted by tens of thousands of doctors and medical scientists.

- ▶ Medically and scientifically, Covid-19 is a Severe Acute Respiratory Syndrome (SARS) Coronavirus 2, and is named (SARS-CoV-2). There are several SARS viruses, and these have been around for many, many years.
- ▶ The actual overall fatality rate of covid - averaged across all ages - is 0.1 - 0.3%. It is lower for people under 60, and higher for people over 60.

 - Dr. John Lee: “A respiratory virus needs associated symptoms in order to be clinically relevant. One year ago, this belief would have been universally accepted by the wider medical community. ... Infectiousness or transmission of a virus requires active infection resulting in high levels of viral replication and shedding. Symptoms, such as coughing, are the real drivers of spread.”

- ▶ Numerous studies have proven that natural immunity is superior to any covid vaccine.
- ▶ Treating covid-19, no matter what variant, is easily treatable at home. For people at high risk or high exposure, early or prophylactic treatment is essential to prevent progression of the disease. According to hundreds of studies, early outpatient treatment of covid significantly reduces hospitalizations and deaths.
- ▶ Age profile: The median age of covid deaths is over 80 years in most Western countries (78 in the US) and about 5% of the deceased had no serious preconditions. The age and risk profile of covid mortality is therefore comparable to normal mortality, but increases it proportionally.
- ▶ Nursing homes: In many Western countries, about 50% of all covid deaths have occurred in nursing homes, which require targeted and humane protection. In some cases, care home residents died not from the coronavirus, but from weeks of stress and isolation.
- ▶ Excess mortality: Overall, the pandemic has increased mortality by 5% to 25% in most Western countries. The majority of additional deaths have NOT been caused by covid, but by government restrictions and lockdowns, as well as an aging population.
- ▶ Symptoms: 85-90% of all infected persons show no symptoms. Overall, about 90% of symptomatic people develop at most mild or moderate symptoms and do not require hospitalization. Early outpatient treatment significantly reduces hospitalizations.
- ▶ Much has been written in the news media and spoken by politicians about the dangers of overcrowded hospitals because of covid-19. There have been many reports of many hospitals swamped with covid patients. Over 90% of these reports are either completely false, or exaggerated. Very few hospitals were overrun with covid at any point over the past 2 years. Those few that were, were overloaded for a short time. The truth is that 98% of all hospitals in the world experienced NO increases over previous years, and NO hospital was ever full or overloaded with only covid patients.
- ▶ Masks: There is still little-to-no scientific evidence for the effectiveness of face masks in the general population, and the introduction of mandatory masks couldn’t contain or slow the epidemic in most countries. If used improperly, masks actually increase the risk of infection.

- ▶ Children and schools: In contrast to influenza, the risk of disease and transmission in children is rather low in the case of covid. There was and is therefore no medical reason for the closure of elementary schools or other measures specifically aimed at children.
- ▶ Testing. The PCR test produce 50-95% false positives, depending on how many amplification cycles are run. In this regard, the so-called cycle threshold or ct value is an important parameter.
- ▶ Virus mutations: Similar to influenza viruses, mutations occur frequently in coronaviruses. Most of these mutations are insignificant, but some of them may increase the transmissibility of the virus.
- ▶ Government lockdowns , mandates and restrictions have caused MORE hospitalizations and deaths than covid.
- ▶ According to the UN, lockdowns put the livelihood of 1.6 billion people at acute risk, and push an additional 150 million children into poverty. And additional 3-5 Million children have died from starvation thanks to lockdowns - over and above the usual 3 Million children who starve to death every year.
- ▶ Sweden. In Sweden, covid mortality in 2020, without lockdown, was comparable to a strong influenza season and BELOW the EU average - where the EU used massive lockdowns and mandates. About 50% of Swedish deaths occurred in nursing homes at the beginning of the pandemic. The median age of Swedish covid deaths was around 84 years. (Section 7)
- ▶ Japan. Japan had one of then lowest fatality rates in the world, with NO lockdowns.
- ▶ Taiwan. Taiwan had one of the lowest fatality rates in the world, with NO lockdowns.
- ▶ Africa. African nations have very low fatality and hospitalization rates, with NO lockdowns and very low vaccination rates.
- ▶ India, the second-most populous nation on earth, has very low hospitalization and death rates, thanks to early treatment with inexpensive and successful treatments that have been proven in hundreds of studies.
