## Preauthorized Electronic Assessment Payment Service Agreement and Disclosure Statement for Electronic Payment of HOA/Condo Assessments

Information regarding payments is reported to the association's management company on the same day funds are deposited to the association's account.

There may be changes to the assessment amounts and/or due dates in accordance with the ASSOCIATION'S governing documents and applicable statutes including notification requirements of the ACH (Automated Clearing House) rules.

We reserve the right to make changes in the agreement at any time. We may cancel Preauthorized Electronic Assessment Payments at any time without cause and you can terminate this agreement at any time by giving sufficient written notice.
