



DEGOUFF K9 LIABILITY/GENERAL CONTRACT

IN CONSIDERATION OF THE SERVICES RENDERED BY DEGOUFF K9 ("DEGOUFF", "OUR", OR "WE") TO MY DOG(S), I ("CLIENT", "I", OR "MY") ACKNOWLEDGE THAT I HAVE READ, UNDERSTAND, AND AGREE TO THE STATEMENTS AND POLICIES SET FORTH HEREIN (THE "AGREEMENT"). BY COMPLETING THE AGREEMENT AT THE BOTTOM OF THIS PAGE, I CONFIRM MY ACCEPTANCE OF THESE TERMS AND AGREE TO THE FOLLOWING POLICY STATEMENTS, EFFECTIVE AS OF THE DATE BELOW. IF I DO NOT AGREE TO ALL THE TERMS AND POLICIES, I UNDERSTAND THAT I SHOULD NOT COMPLETE THIS AGREEMENT AND SHOULD CONTACT DEGOUFF K9 DIRECTLY FOR MORE INFORMATION.

LIABILITY

I UNDERSTAND CERTAIN PROGRAMS THAT MY DOG MAY PARTICIPATE IN, INCLUDING, BUT NOT LIMITED TO, PACK WALKS, OBEDIENCE TRAINING, DAY TRAINING, ONE ON ONE PLAY, MOVEMENT WITHIN AND/OR OUTSIDE THE FACILITY, AND TRANSPORTATION TO AND FROM DEGOUFF K9 INVOLVE RISK AND POSSIBLE INJURY, INCLUDING BUT NOT LIMITED TO: EXPOSURE TO PARASITES, VIRUSES, AND OTHER MEDICAL ISSUES PASSED FROM DOG-TO-DOG OR PERSON-TO-DOG; SPRAINS, STRAINS, BITES, BROKEN BONES; FATIGUE, DEHYDRATION, NICKS, CUTS, OR DEATH. I FURTHER UNDERSTAND THAT NOT EACH AND EVERY POTENTIAL RISK CAN BE LISTED ABOVE BUT, NONETHELESS AGREE THAT THE ACTIVITIES ASSOCIATED WITH DOG SOCIALIZATION AND TRAINING OUTWEIGH THE RISKS. THEREFORE, I HEREBY VOLUNTARILY RELEASE, FOREVER DISCHARGE, AND AGREE TO HOLD HARMLESS AND INDEMNIFY DEGOUFF K9 AND ITS AGENTS, SUCCESSORS AND HEIRS, FROM ANY AND ALL LIABILITY, CLAIMS, DEMANDS, ACTIONS, OR RIGHTS OF ACTION, WHICH ARE RELATED TO, ARISE OUT OF, OR ARE IN A WAY CONNECTED WITH MY DOG'S PARTICIPATION IN ACTIVITIES AT DEGOUFF K9, INCLUDING THOSE ALLEGEDLY ATTRIBUTABLE TO THE NEGLIGENT ACTS OR OMISSIONS OF DEGOUFF K9.

AUTHORIZATION OF MEDICAL CARE

IF MY DOG(S) IS ILL OR INJURED WHILE PARTICIPATING IN ACTIVITIES, AT OR WITH DEGOUFF K9, DEGOUFF K9 WILL MAKE EVERY REASONABLE EFFORT TO REACH ME PURSUANT TO THE CONTACT INFORMATION I HAVE PROVIDED DEGOUFF K9. HOWEVER IF DEGOUFF K9 IS UNABLE TO CONTACT ME, I CONSENT TO DEGOUFF K9 SEEKING APPROPRIATE CARE AND I ACCEPT RESPONSIBILITY FOR ANY AND ALL ASSOCIATED EXPENSES. DEGOUFF K9 WILL NOT PAY ANY PORTION OF VETERINARY EXPENSES ASSOCIATED WITH MEDICAL CARE FOR MY DOG IF SO NECESSARY. I AGREE THAT I WILL DISCLOSE TO DEGOUFF K9 ANY ALLERGIES MY DOG MAY HAVE. I FURTHER AGREE TO DISCLOSE TO DEGOUFF K9 ANY SPECIAL DIETARY NEEDS OR MEDICATION MY DOG MAY REQUIRE IF NECESSARY DURING ACTIVITIES AT DEGOUFF K9.

CANCELLATION

IF A CLIENT FAILS TO GIVE AT LEAST 12 HOURS CANCELLATION NOTICE, OR IS NOT PRESENT AT THE TIME OF SCHEDULED APPOINTMENT, CLIENT WILL NOT BE REIMBURSED THE COST OF THE APPOINTMENT. FOR PACKAGE DEALS, THE SESSION WILL BE COUNTED AS ONE USED SESSION. IN THE EVENT OF HAZARDOUS WEATHER CONDITIONS DETERMINED BY THE SOLE DISCRETION OF DEGOUFF STAFF (I.E. HEAVY RAINFALL, EXTREME HEAT, BELOW FREEZING TEMPS, SNOWSTORMS, HURRICANES, ETC.) THAT MAKE TRAVEL UNSAFE FOR OUR CLIENT OR DEGOUFF K9 STAFF, AND/OR MAKE IT UNSAFE FOR THE DOGS IN OUR CARE, APPOINTMENTS MAY BE CANCELLED BY DEGOUFF K9 WITHOUT PENALTY. CLIENT WILL NOT BE CHARGED FOR SESSIONS CANCELLED BY DEGOUFF K9 DUE TO HAZARDOUS WEATHER CONDITIONS. FOR DAY TRAINS CUT SHORT DUE TO HAZARDOUS WEATHER (DETERMINED BY DEGOUFF STAFF) MORE THAN ONE HOUR PRIOR TO ITS SCHEDULED END TIME, THE SESSION WILL BE RESCHEDULED.
