

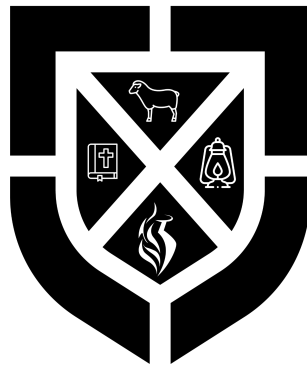

GENERAL POLICIES AND PROCEDURES

Missed Payments

The school will assess a \$30.00 charge on all returned or missed payments. In households of more than one child, the oldest child is considered the first child, the second oldest the second, etc. The first tuition is due on August 15th, 2025 with the remaining payments due on the 5th or 20th of each month through June 2025. There are no discounts for half or full payment of the year's tuition.

Accounts more than **60 days past due** will result in a meeting with the administrator, and students may not be permitted to attend classes until payment arrangements are made. This includes Extended Care fees. Financial emergencies are understandable and should be discussed with the school administration for special consideration. Students should label all their books clearly. Lost textbooks, workbooks, or library books will be replaced at the original cost-plus shipping by the student.

Early Withdraw Fees

When a child is withdrawn before the last day of class, 25% of the original tuition must be paid before records are released. Likewise all fees must be paid in full before the withdrawal process is marked as completed. ***All fees are considered per student**

Records

All academic records will be withheld until all school fees and/or fines are paid. **At each end of the grading period, report cards will be withheld for those students whose accounts are in arrears.** The school will withhold the diploma and transcripts from any graduating senior whose account has not been paid in full prior to the graduation date. In the case of a student's withdrawal by a parent, or a request to withdraw from the school administration, the account will be charged for the full month.

Attendance

The state law mandates at least 170 actual school days/year with 540 net instructional hours for students in kindergarten, 720 net instructional hours for students in grades 1-3, and 900 net instructional hours for students in grades 4-12. Our school offers 180 actual school days or 990 net instructional hours. **Any student in grades K5 - 8 who is absent 20 or more days in a year cannot pass that grade. Any High School student in 9-12 grade who is absent 18 or more days in the year will automatically fail and won't receive any credit.** In the case of a severe, long-term illness, there is an exception; but thorough documentation must be provided by a physician. Please be conscious of this throughout the year.

When a student is absent, a written note is required by the parent or guardian stating the reasons for the absence. This must be given to the office when the student returns to school. **Notes written by students and signed by parents will not be accepted.** Absences are excused for illness, death in the immediate family, extenuating circumstances, or pre-arranged absence. Students will have three days to make up the missed work, beginning on the day they return to school. Unexcused absences will result in zeros for the missed work. No tuition will be refunded due to absences. **After four unexcused absences per Grade Period a warning letter will be sent to the parents.**

After School

After school fees are paid every Friday. If fees are not paid the student won't be accepted the following week. **If a student remains after 5:30 P.M., an additional charge of \$10.00/day will be assessed thereafter. Also, any student not in the extended care program that is not picked up by their parents by 2:10 P.M. will be assessed a charge of \$1.00/minute thereafter.**

Uniforms

Kindergarten: Red polo shirts with our logo and Navy Blue slack or our plaid design.

First to eighth grade: Lake blue polo shirts with our logo and Navy Blue slack or our plaid design.

High School: White polo shirts with our logo and Navy Blue slack or our plaid design.

***GPHCA students must wear uniforms daily. Please note: Leggings are not considered uniforms; therefore, they are not allowed. Unless previously spoken to the principal for special accommodation.**

Lunches: GPHCA will not be providing Free Lunch for the time being. We will make lunch available at a monthly fee.

Application for Admission

I Permissions and Waivers

A. In signing this Parental Commitment Form, we give permission for our child to take part in all school activities, including sporting events, practices, and school-sponsored trips away from the school premises. Further, in the event my child becomes ill or is injured while under school supervision, we authorize the school authorities to take the following steps: a) contact a parent of the student and follow their instructions b) in the event neither parent can be reached, call the person(s) listed on the emergency medical form c) if emergency medical numbers cannot be reached, call EMT unit for emergency medical assistance.

B. We release Gainesville Potter's House Christian Academy, its employees, agents, and representatives from any claim we may have resulting from any illness or injuries sustained by our child while under school supervision whether at school or away from school premises. We further agree to hold harmless Iglesia Casa del Alfarero or Gainesville Potter's House Christian Academy, its employees, agents, and representatives from any injury or damage that may be caused by our child.

II. Statement of Cooperation

A. Our personal acceptance of a commitment to Jesus Christ as Lord and Savior.

B. Our commitment to participate in the Christian education of our son or daughter with regular attendance at a Bible-believing church as a family and by exemplifying Christian principles of life in our home.

C. Our commitment to the Statement of Faith of Gainesville Potter's House Christian Academy and our agreement with the school's efforts to train our child in the Bible and encourage our child in this and in all other phases of the curriculum.

D. Our commitment to honor the policies of Gainesville Potter's House Christian Academy as stated in this document and in the school handbooks.

E. Our commitment to attend all parent meetings and to lend our support to the program.

F. Our commitment to investing authority in the agents of the school to make and enforce school regulations and policies and to discipline our child as necessary.

G. Our commitment to agree that if our child should become involved in any trouble or we disagree with any policy set by the school, we will in no case complain to any other party, and in the spirit of meekness will register only necessary complaints with the teacher or Administration (Matthew 18:15-17; Galatians 6:1-2).

H. Our agreement that should any legal action, for any reason, be taken against Iglesia Casa del Alfarero & Gainesville Potter's House Christian Academy, any employee or agent thereof on my child's behalf, and the church/school or its agent not be found at fault, to pay any attorney fees, damages or other costs that Iglesia Casa del Alfarero & Gainesville Potter's House Christian Academy or its agent should incur to defend themselves against such action.

I. Our agreement is to pay the tuition in 11 monthly payments to begin on August 15, 2025. We understand that a \$30.00 late fee will be added for any payment outstanding. We also agree to pay any assessment for the damage my student may make to school property. We understand that report cards, transfer of records or graduation will not be completed without financial clearance.

J. Our understanding that our child's attendance at Gainesville Potter's House Christian Academy is a privilege and not a right; and that if at any time his/her conduct, behavior, academic progress, or cooperation with the school's authorities is not in keeping with the school's requirements, the school reserves the right to terminate, at its discretion, my child's enrollment.

K. Our agreement is that if the student is voluntarily withdrawn or is requested to withdraw by the school before the school year end, no fees will be refunded, and the account will be charged for 25% of the full tuition amount plus books cost (\$200.00).

L. Gainesville Potter's House Christian Academy reserved the right to retain all student records until all accounting balances were met.

M. Our understanding is that Gainesville Potter's House Christian Academy will use any means to collect any outstanding balance and will apply such in a Biblical manner in a spirit of cooperation and understanding.
