



2021 BREEDING CONTRACT

1. PARTIES

- 1.1 This Breeding Contract is entered into on this day ____ of _____

- 1.2 The Mare Owner is contracting for (Circle One) **Live Cover, On-Site AI or Shipped Cooled Semen.**
- 1.3 Neither party may substitute or transfer this agreement without the prior written consent of the other party. This agreement is for the 2021 breeding season of Customs Pistol Pete and is not to be substituted to any other breeding seasons or mares without prior consent.

2. FEES

- 2.1 A non-refundable Booking Fee of \$200.00 shall reserve one breeding to Customs Pistol Pete and is due at time of booking, with a signed contract and copy of mares papers and lease agreement (if applicable) of mare. The payment is accepted via Cash, Check or PayPal. In the case of insufficient funds available, Mare owner agrees to pay a \$25.00 NSF Return Item Fee.
- 2.2 The total Stallion Service Fee of \$950.00 includes Collection, Booking and First shipment cost. The shipping cost for subsequent services will be responsibility of the Mare owner (unless otherwise agreed upon by the Stallion owner and Mare owner). All fees shall be paid upon receipt of invoice and prior to any agreed scheduled shipment.
- 2.3 For on-site AI services the Mare Owner will deliver the Mare to Right Lead Ranch on or about the following date _____.

2.4 Mare Owner agrees to pay the following boarding fees for time mare or mare and foal are at Right Lead Ranch (all mare care payments are to be made to **Right Lead Ranch**):

Monthly Mare Care Fee	\$450.00/month
Daily Mare Care (under 30 days)	\$15.00/day

2.5 For on-site services/boarding the Mare Owner will be notified and asked prior to any veterinary care, drugs or hormones being administered. Mare Owner will be billed separately by Right Lead Ranch and the Veterinary office.

2.6 Breeder's Certificate. A breeder's certificate will be released or issued to the Mare Owner after all fees and expenses have been paid in full.

3. Live Foal Guarantee

3.1 The Stallion Owner offers a Live Foal guarantee. This guarantee is only honored if the stallion service fees, mare care, and deposits set forth have been paid in full. A Live Foal is defined as a foal that will stand and nurse without assistance or is able to be bottle fed.

3.2 In the event the Mare does not deliver a live foal or becomes unable to inseminate during the breeding season, the Mare Owner shall be entitled to one additional breeding to the same Stallion. This breeding will be provided in the first or second subsequent breeding season to this contract and are subject to the provisions of this Agreement. The mare owner agrees to pay only the shipping fees in effect for the following season.

3.3 The Live Foal guarantee shall be void and the Stallion Owner released from any liability or obligation in the event that:

- The Mare is sold by the Mare Owner prior to foaling unless Stallion Owner agrees in writing to continue the Live Foal Guarantee.
- Mare Owner breaches any representations or warranties as set forth in this agreement.
- Mare's failure to give birth to a live foal is due to the actions or inactions of Mare Owner.
- Mare Owner does not provide a veterinarian confirmed document to Stallion Owner within 30 days of the date the Mare aborts her foal or delivers a stillborn foal.

4. Mare Condition

- 4.1 Mare owner affirms the mare is in sound breeding condition and free from any disease or infection that will affect other equine or the birth of a live foal.
- 4.2 For on-site AI: Mare Owner warrants the Mare is halter broke and not a danger to the staff of Right Lead Ranch or Veterinarian performing AI.
- 4.3 Mare Owner shall provide to Stallion Owner and staff at Right Lead Ranch a veterinarian's health certificate, list of current shots and a current negative Coggins test prior to transporting the Mare to Right Lead Ranch for breeding.

**** It is highly recommended mares are confirmed ovulating prior to arriving for On-Site AI/Live Cover services. ****

5. Termination of the Agreement

- 5.1 Mare Owner shall have the right to terminate this agreement for any reason whatsoever upon providing 7 (days) prior written notice to Stallion Owner.
- 5.2 Stallion Owner may terminate this agreement in the event they determine Mare Owner breached the agreement or any misrepresentations. The Termination shall occur upon 7 day's written notice to the Mare Owner.

6. SIGNATURES

The Parties agree to the terms and conditions set forth in this contract and understand upon signing that it is binding as of the day and year documented in section 1.1.
