### CANCELLATION AND REFUND POLICY

We allow for the eventuality that a customer may need to change or cancel a tour. If notification is received at least 30 days prior to the scheduled tour I will try to rebook you for another time. Canceling within 30 day(s) of the scheduled departure is a 100% percent cancellation fee.

## ACTIVITIES AND LIABILITY WAIVER

All participants must ensure they are medically and physically fit for travel; walking a few miles per day and getting on and off a boat. Participants are required to advise the provider, in advance, of any physical, medical or other special needs that require accommodating. All participants were informed that there is no medical problem that makes their participation in the activity problematic (Allergic, cardiology, etc.), pregnancy or disability that prevents them from participating in activities such as walking and boating.

The tour guide will maintain a high level of safety throughout the activities. To enable the guide to manage these risks you agree to acknowledge the need for responsible behavior and that the guide's word is final say on all matters of safety.

Activities in nature include exposure to the elements, to animals and have the potential of personal injury. You are aware of and accept these risks and will be responsible for your actions. By choosing to attend our tour, you are accepting certain risks. This signed form shall serve as a release of our liability and a complete assumption of all risks by you and your heirs, administrator, executor, successors, and assign for all family members. By accepting our terms of service with the signature of this waiver, you fully acknowledge that you are aware that travel involves some inherent risk of injury, illness, death, loss, or damage to personal property, which may be caused by acts of nature, negligence or actions of others. If you are deemed not capable to the extent that such state or condition is materially likely to endanger the safety or enjoyment of other participants, you will be removed from the tour with no refund given.
