The 2022 Audit review is underway don't expect a report until early May 2023 We are still low on fund and have to control our spending over the next few months. **Motion**: that we employ Jamie Araujo of Ellis Group LLP to complete our 2021 Year End Audit for an amount not to exceed \$9,000.00 00 including GST

BMO Business Proposal

We can have as many accounts as we need at no cost

The mortgage balance \$1,520,000 will be transferred to BMO at Prime +1.27 = 7.97% Monthly payment of \$5066.67 + interest. Currently we are paying \$10,151 and an interest of \$4,698.51. We are trying to get it amortized for 25 years, which will lower the payments. We can pay down the principle at any time with no fee.

The \$80,000 Operating Demand Loan interest at 6.7 + 0.29 = 7.99%. Currently it is 6.7 + 0.5 = 7.2%.

We can have two company credit cards for a total balance of \$25,000.
