## **COMMITTEE REPORTS**

**FINANCIAL CHAIRMAN:** Comrade Kuervers reported

1. Meeting open at 1152 (early by consensus).
2. Discussion by Financial Chair. We discussed that it had been too long since the last Financial Committee meeting. In addition, it is good for us to catch up and stay synchronized. Finally, the chair announced that he would be away from 28 Jul - 20 August. (Post meeting note: The chair returned 10 August, due to a shifted work schedule.)
3. No update to the Treasurer report issued Tuesday 20 Aug.
4. Old Business and Standing Topics:
  - a. Taxes - remains with the First Vice. Discussions with the City of Edmonton are ongoing. An updated tax bill has been received.
  - b. Rent subsidies and wage subsidies update by Gary Forner. This will continue until September. The Wage/Rent subsidy for June was submitted.
  - c. Bingo finances. The existing split finances for Bingo's have been identified as breaking AGLC regulations. The Finance Chair and the Sports Chair will write a co-letter to the various sub-entities and the Ladies Auxiliary explaining the situation, after it is discussed at the next executive meeting.
  - d. Tracking of expenses for Legion Class Action regarding insurance. No change - currently being tracked by Ron Wills;
  - e. AGLC audit. Report has been received and approved by President, closed matter.
  - f. Budget. Under review. Discussion on using last years budget. Decision on authority to issue budget, based on the last year budget (less a casino) was agreed to by the committee. A more detailed budget is required for next fiscal year.
  - g. Mortgage. Standing topic, tabled as there are no new points.
  - h. Line of Credit. New standing topic tabled as there are no new points.
  - i. Payback of federal loan by Dec 2022. Standing topic. Currently there is 17k free in the Line of Credit.
5. New Business:
  - a. Review of business practices. Discussion on way forward:
    - i. The committee will develop on SOP for movement of Monies IAW AGLC policies and to protect gaming funds from misallocation.
    - ii. Further discussions were tabled until the next Committee meeting.
  - b. M109 Controlled Goods status. The Chair identified and discussed the fact that the CG costs (proper certification for personnel within the branch) is "Maintenance of a monument", and as such is something that can be requested and funded out of Poppy Funds. This topic will remain open as a Standing Topic until the issue is closed; and

- c. Non-Profit Status as per the Minister of Finance. This file is in the hands of the First Vice and will be presented to the Executive when facts are collected.
- 6. Round table on financial outlook. Looking for viewpoints on our current viability, etc. The Committee agreed that despite COVID, we are breaking even, due to offsets in subsidies and climbing member attendance to events. A concern was raised about the proper billing of internal events against gaming funds.
- 7. Next Meeting. Scheduled for 24 1730 August 2021. (Post meeting notes: Meeting was cancelled at request of Chair due to other commitments of some members). New meeting will be scheduled separately. I so move my report.

**ENTERTAINMENT & SPECIAL EVENTS:** Comrade Rayfield

1. I have booked the Edmonton Swing Band, an 18-piece orchestra, for the 75th Anniversary Dinner and Dance.
2. I've been tracking the number of customers and cover charge revenue generated by all of the bands, along with bar & food sales.
3. If there is a noticeable trend, I will consider replacing and/or enlisting 1 or 2 additional new bands.
4. I've been searching for a band or DJ to provide entertainment for a Downhomer's Night with Irish/Maritime type folk music.
5. I have consulted with my son, who is a Regional Sales Manager for a large flooring manufacturer, for an estimate to enlarge the canteen dance floor without losing any seating capacity.
6. His company, approves and provides grants for flooring upgrades up to 500 sq. ft. for not-for-profit organizations, up to \$4500, thus we would qualify to have most of this project completed at no cost.
7. I would like Board approval to procure suitable darker window coverings for the canteen stage.
8. Also I'd ask for approval for the procurement of the portable staging previously discussed. My hope would be to have it shipped in time for the 75th Anniversary Dinner and Dance, as well as New Years Eve. I so move my report.

6. We were charged \$150.00 for a false alarm on August 2nd some guy couldn't get in the building the front doors said closed so he tried the side door and the handy cap lock on that door was not locked and he came inside and set off the alarm.
7. Our insurance is coming due in October I don't have a price yet but it did go up \$2000.00 last year.


