Our next event is a Parking Lot dance on either Aug 27 or 28. Music by Vinyl Country. The proposal has been submitted to AHS. We should get a reply back by Aug 19 or 20.

As of July 31, 2020, all Tribute Concerts have been refunded with maybe the exception of a couple of ticket holders that want to exchange them for the next show.

Our next ticketed event will be held on Sept 11 and Sept 12. The RJ RADIO SHOW. The Canteen table plan has been re-visited to accommodate the Social Distancing requirements. Our October event has a Hypnotist scheduled for 1 night and a DJ "BEST BY REQUEST" night for the second date on the weekend. A Proposal has been submitted to AHS. Results due back Aug 20. Dates will be finalized once approval received from AHS.

It is strongly felt that we have the correct procedures in place to hold events such as our Tribute Concerts. I will approach AHS again to seek their permission after Aug 22.

During the week of August 24, I will begin signing up the Canteen Bands for 2021 calendar year, if the restrictions are lifted. I so move my report

## **BUSINESS MANAGER'S REPORT:**

Our new App Get In The Loop has reached 64,062 subscribers, but the results have been none to minimal at best. It is our intent to drop this subscription. Our image and branding are still a problem in our effort to attract the younger demographics. Currently, I think it best that we continue to view the legion for what it is and make it a much more viable place with the crowds we do attract and get more of these to attend.

Friday Afternoon Food and Drink specials have good results for July.

Our attendance for the month of July is at 1275 people(300/Week)

I will post a new skin on our Billboards to advertise the RJ RADIO SHOW.

Our Video Project is postponed until later 2021 due to COVID concerns. We are instead being invited to 30 second free commercials for the Legion on TANG RADIO.

Canteen tables have been reset to Social Distancing requirements. We should observe the seating plans that have been set up. In the event of Sports Events such as Darts, we can remove or temporarily reset the tables to accommodate the event and place back after the event. Our ticketed events will be pre-sold on the "Bubble or Co-Hort" concept and the seating requirements will be adjusted accordingly.

I recommend that we save all the rectangular tables in the Canteen for future use in the Ballrooms. The table design is better suited to provide the social distancing we need for Covid and for better facility utilization for our concerts.

Our new tables will be delivered on August 24<sup>th</sup>, in the Maple Leaf Room. We can store the large round tables in the storage room and set up the new tables. The new tables will make it easier to set up according to AHS for any functions. I so move my report Seconded by Comrade Earles

# **PRESIDENT'S REPORT:** Comrade Wills reported:

Comrade Wills advised the Executive his feelings about the membership attending Executive. Unless you submit a request one week prior to the meeting and it is approved you will not be able to attend the meeting.

During the General Meetings we open the floor for the Good and Welfare this is specifically for the membership to express their views or bring up items. I so move my report.

#### **OLD BUSINESS:**

Comrade Kuervers reported we re-signed the mortgage, as discussed at the last meeting. We were not able to negotiate a better rate but we still received a much better rate the pre covid.

We were able to increase the overdraft, we added the old overdraft to the mortgage and increased the overdraft by double. It is not our intent we do not use the entire overdraft.

Comrade Wills reported we are due for a letter of authority, as ours expires in January. We will be applying for a new letter of authority as soon as possible.

Hours – we are not getting the number of people we thought would be coming back to the Legion. We are still at 40 mark on average per day, 55 - 60 on a Friday night. Saturday is very low, especially after the meat draw. There is no one here in the evening.

I do not think we should change the hours at all. Hopefully in September, people will be coming back, we are starting our Pool, Shuffleboard and Dart teams in September. But all teams must abide by AHS rules, social distancing and masks must be worn.

Comrade Wills has suggested that we attach a copy of our reply to the Friday Night Shuffleboard to these minutes, so that members can see we did not ignore them we answered their complaint.

The Veteran's Association Food Bank, Comrade Wills discussed this with Command and this was their response. The Veteran's Association Food Bank is a Calgary organization which we do not encourage engagement with. Unfortunately, key players in the said organization were responsible for accusing the Legion of many falsehoods in the media, removing confidential information from the Calgary Branch Poppy Office and used the Legion Poppy Campaign to gardening funds by which misrepresenting themselves. We did not take legal action due to cost of litigation. So, based on that statement we will not be dealing with Veteran's Association Food Bank.

Camera's – Comrade Kuervers reported we have 3 camera's that are down at least 2 for positive are down the 1 in the ballroom may be repairable. I have a quote for \$295 each from a reliable company, they are prepared to come in and quote the entire system after the fact, so it would be the same camera's we hope to buy.

Good day members of the Shuffleboard League,

I am writing to you in response to the letter dated 9 July from Marge Wyatt in concerning the movement of one shuffleboard table, after it was discussed during the Executive Meeting on 21 July 2020.

Let me first state that this decision was made by the Executive, with no input from any of the three shuffleboard leagues. The decision to move the shuffleboard was based on a couple of factors:

- 1. There has in recent years, been a growing concern by shuffleboard players about the pool players continually using the shuffleboard tables as a place to lean despite many requests not to do so;
- 2. The Friday Night League has expressed their concern about the location of the table used for collecting admission fees for the Friday Night Dance and how it limits their movement;
- 3. The impediment of other Legion members trying to get to the bar when entering the canteen; and
- 4. In accordance with AHS Guidelines regarding COVID19, we are not allowed to use both tables (as they were located) at the same time.

The Executive did not make this decision lightly.

On a trial basis, we decided to move one table in hope that it would eliminate these issues. In December 2020 or January 2021, a decision will be required as to the whether or not to keep the current setup, change it back to the way it was, or relocate the tables elsewhere. If social distancing rules are still in place, the decision will be delayed accordingly.

I would now like to address some of Marge's comments/concerns in the letter.

Marge mentioned that sitting together was a benefit that would be lost if the tables are kept the way they currently are. In accordance with AHS Guidelines during the COVID19 emergency, we are restricted to a maximum of six people to a table and those members sitting at the tables must be a minimum of 6' from other tables. That means we need a clearance of 10' between tables to meet that requirement, and the canteen has already been adjusted for this. Based on the guidelines, your group will need a minimum of four tables. We acknowledge that this will make communicating with anyone that is not at the table next to you very difficult, however, due to the circumstances, all of our sports leagues and the members themselves will be forced to adapt. When we are able to return the canteen to the normal configuration, we will continue to reserve tables for your use.

It was also identified that it would make the Draw Master's job more difficult. Based on standard Legion Shuffleboard sports practices, we do not understand your concern. Normally, the players would still be sitting at the table until their name is called. The players then go to the respective table and begin to play. Once the game is over the players report to the Draw Master with their score or loss/ win status.

In addition, you also mentioned that "for the last several years enjoyed the comraderie of sitting near each other and having a lot of fun. This is hard to do when we are not in the same vicinity. Couples sit together but do not play as partners so splitting up the shuffleboard table play times would certainly not be doable." The league would still be sitting together or as close as they can within the AHS restrictions.

You should also know, that in an effort to increase attendance, we have also moved Fri/Sat night dances to the Maple Room. This is due to reports from the staff and the executive that members are coming to the dance and leaving because there are no available seats. Once again, this is contingent upon COVID19 restrictions being lifted and will be considered on a trial basis. In the event that the Maple Room is already booked for a function that can help the branch raise additional funds, the dance move back to the canteen for that night. As a side benefit, the admission table will not be required, allowing for easier movement by shuffleboard players.

We know that the change was a bit of a shock but we are asking that you give the new layout a try before condemning it.

In addition, in an email addressed to Gary Forner, a member of the Executive, dated 17 July 2020, Marge stated "If the relocation of one of the boards stays as it is, there will be no league in the future."

As for not renewing your membership in December if the layout is not returned to the previous configuration, you should know that that is your decision, but we will not be making decisions about our Legion based on threats, but as a matter of business and safety for all members.

It is our belief that the benefits of being a Legion member would outweigh any minor frustrations you may feel on this matter. If you wish to discuss this further, we encourage you to contact the undersigned at your convenience in writing.
