COMMITTEE REPORTS

FINANCIAL CHAIRMAN: Comrade Kuervers Financial Committee Report

Comrades, as you know, I am Steve Kuervers, the First Vice-President. I am also the Chair of the Financial Committee.

Overview. The last six months have been stressful times for our Legion. I will quickly cover key decisions and actions taken over this timeframe in this report. I want to cover four major points separate from our financial report which be presented by the treasurer.

Success in the COVID environment. A large part of our Legions success is because we are blessed with both a fairly large canteen that can handle our membership clientele in a dispersed manner, and the fact that our rental facilities are scaled from small (boardroom) to medium (small dining/dance room) to large (large dining/dance room) to full (temporary wall removed between the two dining/dance rooms), which has allowed us to return to normal business operations quicker than a smaller facility could.

Impact. COVID 19 has had an immediate and substantial affect on our business operations, but our Executive, ably lead by our President, was quick to step into the situation, taking efforts to mitigate the effect on our income and operations immediately, and creating contingency plans that were implemented as government restrictions were added. In addition, we have opted to view this event as an opportunity, which has allowed us to increase our use of volunteers and provided us the perspective to step back and review our business processes as a chance for both renewal and a confirmation of actual day-to-day expenses and requirements.

Future. Our primary concern moving forward is the continuing impact of COVID19 on future entertainment events and hired events (such as weddings), which are a significant funding stream in our facility. However, we are fortunate in that we can mitigate the financial risk of these lost events fairly easily, because we do not have permanent staffing, kitchen or contracted resources assigned to the banquet and meeting rooms - these resources are assigned by event, separate from the routine staffing and kitchen resources which support our members areas, Legion offices, and daily use facilities.

Government Resources. We are using the Federal Canadian Employee Wage Subsidy (CEWS) subsidy program for all returning employees, offsetting our interim staffing expenses until revenue grows. We took advantage of the Canadian Emergency Business Account (CERB) at the federal level. Note that we intend to return the CERB loan before December 2022, which

will result in a \$10k return to the Legion, as we only need to pay 75% of the loan back. Also, in accordance with interim AGLC policies, we have been able to utilize up to 100% of gaming funds against operational costs. Finally, we have received an \$8000 grant from the RCL Dominion level to offset operational costs.

Conclusion. We continue to react to government support program changes, to health policies, and to identify and apply for grants. Finally, I would like to publicly recognize Ron Wills, our President, who has truly excelled at his leadership and research efforts this last six months - Ron has basically worked full time, spending hours upon hours studying the Legion, Federal and Provincial aid programs, and has quite honestly lead the way for the finance committee.
