Veteran of the Month – S. Danyi

Trooper Michael Yuki Hayakaze served with distinction in the Canadian Armed Forces as a member of Lord Strathcona's Horse (Royal Canadians), an armoured regiment based in Edmonton, Alberta.

In late 2007, Trooper Hayakaze deployed to Afghanistan as a Leopard 2 tank driver with C Squadron. On March 2, 2008, while conducting a supply mission in the Mushan region of Panjwayi District, approximately 45 kilometres west of Kandahar City, his armoured vehicle struck an improvised explosive device. Though he was evacuated by helicopter, he succumbed to his injuries upon arrival at Kandahar Airfield.

Trooper Hayakaze is remembered by his peers and commanders as an enthusiastic, capable, and well-liked soldier. He was known for his willingness to support his team, his eagerness to learn, and his positive attitude in the face of adversity. His contributions during pre-deployment training and operational service were invaluable to his squadron's cohesion and effectiveness.

Posthumously, Trooper Hayakaze was awarded several honours in recognition of his sacrifice. His name continues to be honoured by his regiment and the broader military community. Trooper Hayakaze's legacy serves as a powerful reminder of the courage and commitment exemplified by those who serve Canada in uniform.

Comrade MacIntosh — also on that one to give a tighter breakdown, I am not showing those numbers. I am showing from January 9 to the 10 of April from the daily sales report \$1,195.00 hit the bank. An average of \$91.92 and in the month of March 3 weeks, nothing out of 4. We pulled the daily sale reports for those weeks.

Comrade O'Brien – I don't know. We put the money in. All I can do is put it in my red pouch. Comrade MacIntosh – You put in \$3720? Where did you get that money from? When you looked

across from you door and expenses I believe your 50/50 you are not making 3720.

Comrade O'Brien – you are forgetting the bar

Comrade MacIntosh – you are not depositing the bar

Comrade O'Brien - no

Comrade MacIntosh – so that did not go in your pouch

Comrade O'Brien - no

Comrade MacIntosh – exactly. So \$91.02 is the average that went in per week. And there were weeks that nothing went in – there was a negative. Two weeks at a negative and the week in between made \$55 and that went against the \$95 negative from the week before still not making up that amount.

Comrade Etmanski – Everyone just pays \$10 across the board?

Comrade Luce – it is like the Comedy night – everybody just pays the same amount

POPPY: Comrade D. MacIntosh

Not much of a report. There was no poppy committee meeting for me to go to. Rick and Jackie may have more information for you on the executive meeting. We would like sell the indigenous pins at both the Rally and Convention if we can get a contact I will get a hold of them at both those locations. The thing with that is the Legions might feel there is a conflict because every Legion sells indigenous pins and they are selling them at retail price. We are trying to sell ours at wholesale. Preferably we are not looking to sell them in ones or twos we are looking to sell them to supply the Legions. So it would be a lesser price than they could order them for but I think we really do need to ask permission to do so because of the conflict that they already sell them there. I think we sell them here at \$10 each so we are selling them wholesale at \$5 per pin. If you order more than 100 pins they are \$4 plus shipping and handling. We are asking for \$5 to cover what

we had paid for them. Most Legions I don't think order a 100 at a time the price for less than 100 goes up. So we are offering a break to them.
