Starting on page 3 Statement of Operations, so the revenues in 2024 are down slightly from 2023, about \$30,000.00. A couple of changes within the revenue categories. Gaming is up because of the casino in 2024, so that is way up from 2023. Rentals are up as well. Special events which improves the costs of all the various activities that events that occur over the weekends throughout the year is down. So that has gone the other way. So overall you are down \$30,000.00 in revenues.

On the operating expense side, you are slightly up. The biggest cost obviously being wages and benefits. The second item under expenses Amortization is also called depreciation. So that is not cash outflow, that is just allocating the cost with the building that was purchased years ago. If we add back the amortization, the depreciation of \$384000 in 2024 back onto the deficit that you see at the bottom there, \$424,000 you are actually at a \$40,000 deficit for the year on a cash basis. I just want to highlight a couple of things under operating expenses which I did last year. So within the operating expenses, basically, you can group up all the building costs – so things like property taxes, insurance, repairs and maintenance, interest on the loan, utilities and the cleaning or janitorial costs. So if you group those in it is just shy of \$450,000 in 2024, which is roughly the same as the year before. So your building costs, just to operate the building, is roughly a quarter of your total costs (25%). So as a Board keep that in mind when you are budgeting because those are fixed for the most part. Property taxes are fixed, insurance is fixed, repairs and maintenance there is a little bit of wiggle room there, mortgage interest you can expect that to continue to be where it is at until the renewal, utilities is down but that does not mean that won't go back up again. I think that was just a blip, because when I go back to 5 years ago, it was you know, averaging about 120. Then the cleaning contract that you have for the building. It is probably no a bad idea in reporting each month to have a look at that just to see you are recovering those costs. So not a terrible year, just, you know, not quite break even. The year before was a little bit better. The 2023 year end was \$390,000 deficit but if you add back the depreciation we are actually closer to about \$14,000 surplus in 2023. So things have slipped a little bit in 2024.

If we go to the next page so it is just a small section there and it is just sowing the balances all time so it is basically from day one. Nothing terribly exciting there.

If you flip to the next page, the balance sheet, so just a couple of things to highlight. You do not have your savings term deposit anymore. It was all used up in 2024. You can see under short term investments under current liabilities we are down to nothing there. Inventory pretty well stays relatively constant from year to year. The prepaid expenses, the \$13,000 is a requirement from EPCOR to have a deposit on hand. So that is \$13,000 that is being held by EPCOR. If we go down to current liabilities your bank loan as at December 31 was \$1,438,934. So right now it is being amortized at about 25 years so if you do not renew it let's say you theoretically it would be another 25 years to pay this off but I think the renewal period is coming up so hopefully interest rates will be coming down and you will be able to negotiate a better interest rate. Because right now you are - \$60,000 is going towards the principle and as we saw earlier about \$118,000 is interest. So that is a big chuck of change.

Accounts payable, so basically anything that vendors sent for services that they sent the Legion has accrued, and I checked those numbers, so there is \$72,000 there, wages and benefits, just some wages that got paid at the end of the year, so we had to approve that. Some deposits for banquet activities like weddings and any other activities where groups provided a deposit so that is \$3400 there. Under deferred revenue the sports clubs that you have, that you maintain funds for we have it up here in cash and we also have it down here in under liabilities. I do not really want to go through to much I detail and that is just the highlights. The notes that you see at the end there, they are just basically explaining the numbers or just providing additional information.

# **Veteran of the Month** – S. Danyi

Captain Nichola Kathleen Sarah Goddard, MSM, was a distinguished Canadian Armed Forces (CAF) officer who made history as the first female Canadian soldier killed in combat while serving in Afghanistan. Her bravery, leadership, and dedication to her mission earned her national recognition and several honours.

Born on May 2, 1980, in Madang, Papua New Guinea, Nichola Goddard grew up in Canada, developing a passion for service and leadership. She attended the Royal Military College of Canada (RMC) in Kingston, Ontario, where she excelled in academics and military training. Upon graduation, she was commissioned as an artillery officer in the Canadian Army.

Captain Goddard was deployed to Afghanistan in 2006 as part of Operation Athena, serving with the 1st Regiment, Royal Canadian Horse Artillery. She was assigned to Task Force Afghanistan as a forward observation officer, providing critical artillery support to Canadian and coalition forces.

On May 17, 2006, Captain Goddard was leading a team in the Panjwayi district of Kandahar Province during an intense battle against Taliban insurgents. While coordinating artillery and air support for ground forces, she was killed by a rocket-propelled grenade (RPG) attack. She was the first female Canadian combat soldier to die in action.

For her courage and service, Captain Goddard was posthumously awarded the Meritorious Service Medal (MSM), recognising her exceptional dedication and leadership in Afghanistan. Her sacrifice also led to several tributes, including:

- The Captain Nichola Goddard Fund, supporting programs for women and Indigenous youth.
- Nichola Goddard Middle School in Calgary, Alberta.
- The Nichola Goddard Leadership Award, which supports young leaders in the armed forces.

Captain Nichola Goddard's legacy continues to inspire Canadians, particularly women in the military. Her service demonstrated unwavering dedication, courage, and leadership, making her one of Canada's most honoured female veterans.

# **RESOLUTION #1**

# **SUBJECT:** Resolution for Amendment to the Royal Canadian Legion – Poppy Manual

**WHEREAS** the annual Poppy Campaign is the most important Branch project of the year and it must be conducted by a committee dedicated to this purpose (s. 301);

WHEREAS the Royal Canadian Legion – Poppy Manual provides guidance on the requirements and responsibilities associated with the oversight of the Poppy Campaign and management of Poppy Trust Funds;

WHEREAS it is the responsibility of each Branch President to ensure that Poppy Trust Funds are accounted for in accordance with Section 1102 – 1104 and Section 1206 of the General By-Laws (s.208.f.);

**WHEREAS** the Poppy Manual - Approved Use of Poppy Trust Funds (s. 402) details that contact be made with Provincial Command when unsure of approved uses of Poppy Trust Funds;

**WHEREAS** the Poppy Manual – Approved Use of Poppy Trust Funds (s.402 c.) provides details as to "reasonable local administrative costs associated with the Poppy Campaign";

**WHEREAS** the clarification and additional guidance for administrative expense management for ongoing Poppy Trust Fund management would support efficient and effective management of the Poppy Trust Funds by the Branches and the Poppy and Remembrance Day Committee(s);

# THEREFORE, BE IT RESOLVED THAT:

The Poppy Manual – Approved Use of Poppy Trust Funds (s.402) be amended to include:

# **402.ix Poppy Trust Fund Administration**

Reasonable administrative expenses not to exceed 2% of the Poppy Trust Funds held on deposit as of September 30<sup>th</sup> (prior to the start of the Poppy Campaign) may be utilized for the ongoing administrative expenses for management of Poppy Trust Funds throughout the year that are incurred by and for the Poppy and Remembrance Day Committee.

Any assets purchased to support the management of Poppy Trust Funds will be clearly identified as Poppy Trust Fund assets and be available/accessible to Poppy and Remembrance Day personnel and the Branch Service Officer(s) to support veteran requests and Command submissions.

#### **RESOLUTION #2**

**SUBJECT:** Inclusion of the Indigenous Poppy Pin in the approved Poppy promotional materials from Command.

Canada's Indigenous people have a long history of military service, from the time of the American Revolution to the modern era. Joseph Brant fought alongside the Loyalists to prevent the spread of the revolution into what is now Canada. Four generations later, his great-great-grandson, Lt. Cameron Brandt died in the battle at Ypres. Down through the years, such heroes as Tecumseh, who died in 1813 at the Battle of the Thames, George McLean, a veteran of the Boer War who was wounded in heroic action at Vimy Ridge, and World War II and Korean Veteran Tommy Prince, recipient of the Military Medal and the Silver Star, exemplify the commitment to principles that are essential to the fabric of Canadian Society today. The Royal Canadian Legion is honoured to recognize the contributions of today's Indigenous Members of the Canadian Forces as well as their ancestors.

The Royal Canadian Legion has chosen to recognize Canada's Indigenous Veterans and the significant contribution they have made through our long history and that they continue to make today. This commemorative pin presents the Legion Poppy on the centre of a dreamcatcher, their coupling acknowledging the efforts and sacrifices of Veterans from all of our Indigenous Communities

**WHEREAS**: the annual Poppy Campaign is the most important Branch project of the year and it must be conducted by a committee dedicated to this purpose(s. 301);

**WHEREAS:** the Poppy Manual- Approved Use of Poppy Trust Funds(s 402) details that contact be made with Provincial Command When unsure of approved uses of Poppy Trust Funds;

**WHEREAS**: the Poppy Manual- Approved Use of Poppy Trust Funds(s 402 i Campaign a) details the purchase of Command approved Poppies, wreaths, a ribbon machine and ribbon supplies, canvasing supplies and promotional materials for the annual Poppy Campaign.

**THEREFORE, BE IT RESOLVED THAT**: the Poppy Manual- Approved Use of Poppy Trust Funds(s 402 i Campaign a) be amended to include the Indigenous Poppy Pins.

The inclusion of these pins will show respect to the Indigenous Veterans and allow for a possible increase in Poppy revenue. The sale of these pins during the Poppy Campaign will not deter from the original Poppy as many veterans, members and the general public wear both during the Remembrance/Poppy Campaign time frame.

#### **RESOLUTION #3**

**SUBJECT:** Payment terminal (debit machine) for exclusive use of the Poppy Campaign This would be a benefit to the Poppy Campaign as most people have moved away from writing cheques and do not tend to carry cash. A payment terminal will allow for donations to be made in any denomination the donor chooses and not be limited to the \$2, \$5, and \$10 choices available on the tap machines. Wreath payments are easily processed through a payment terminal as well. Payments made this way are confirmed instantly avoiding the wait time for cheques to clear and allowing for receipts to be issued immediately for those Poppy organizations or Legions with a CRA Tax receipt capability.

**WHEREAS**: the annual Poppy Campaign is the most important Branch project of the year and it must be conducted by a committee dedicated to this purpose (s. 301);

**WHEREAS:** the Poppy Manual- Approved Use of Poppy Trust Funds (s 402) details that contact be made with Provincial Command when unsure of approved uses of Poppy Trust Funds;

WHEREAS: the Poppy Manual- Approved Use of Poppy Trust Funds (s 402 c) reads: reasonable local administrative costs associated with the Poppy Campaign. These local costs are those directly related to the campaign such as telephone charges, coin wrappers, postage, stationary, advertising, bank charges and transaction fees for fees associated with Poppy related transactions. No expense related to the rental or purchase of a POS machine is allowed as these are not expenses that would be exclusive to the Poppy Campaign.

**THEREFORE, BE IT RESOLVED THAT:** the Poppy Manual- Approved Use of Poppy Trust Funds(s 402 c) be amended to include payment terminals/debit machines and associated fees provided the terminal is for the exclusive use of deposits to the Poppy Trust Fund Account.

The above three (3) Resolutions are recommended by the Executive to put forth at the General Meeting on Tuesday, March 25, 2025.
