


Half Season



COMMITMENT

PRACTICES

As a general rule, teams will practice two times a week, for two hours at a time. Once in competition season, additional practices, although infrequent, may be required as needed.

although infrequent, may be required as needed.

Practices are mandatory. Three (3) absences are permitted during the season; repeated and/or consistent absences during the half

season may prohibit progression as a team, negatively impact a team's positive team dynamic, and can ultimately affect the athlete's contributory role and/or placement on their team.

Examples of excused absences include: illness, family emergency, major family events, school sponsored commitment required for a grade, injury that

prohibits attendance, family vacation with advanced two-week notice.

Anything not included in the aforementioned will be considered unexcused. Certainly, extenuating circumstances can be assessed on a case by case basis.

Practices two weeks prior to a competition date are exceptionally crucial; should an athlete miss a practice during this time, for any reason, it is at the coaches discretion should that athlete compete in the upcoming competition.

Missed practices, for any reason, will not be cause for refund.

The expectation for practice is that athletes arrive on time, dressed appropriately, maintain a positive and productive relationship with teammates and coaches, and give 100% every time.

Practices are closed to spectators; occasionally, we will host observation days in which spectators will be permitted.



EXPECTATIONS

INJURY/MEDICAL

Should an athlete suffer an injury or any medical condition that prohibits them from fully participating at at a competition or from more than one (1) practice (i.e. having to "sit out" of a practice or any portion of a practice), a doctor's note must be presented to the coaches/staff. The doctor's note must include the diagnosis, prognosis, and a release from those restrictions must also be provided in order to return to participation.

CHARACTER, CONTRIBUTION, COMPETITION

Athletes and families are expected to represent the UA brand and program with the utmost of integrity, respect, and sportsmanship while associated (with the gym). This includes but is not limited to interactions on all social media platforms. Repeated failure to comply with these standards may result in dismissal from the program.



EXPECTATIONS

COMPETITIONS

Competitions are mandatory. If for some reason an athlete is unable to attend a competition, we graciously ask for advanced notice when applicable to allow for proper preparation of an alternate athlete or routine adjustments. Competition fees will not be refunded should an athlete not participate

for any given reason.

Athletes are expected to arrive at competitions at their designated meet time, in uniform, competition hair/makeup, and fully prepared for the day. This includes proper nutrition (i.e. breakfast, lunch, or dinner depending on the designated meet time) and hydration.

Throughout the event, the expectation of those representing UA is that they reflect the sportsmanship ideals and standards set forth by the brand, coaches, and staff.

We will designate one person to record all performances as to allow the spectators/parents to be fully engaged in their team's performance, cheering for the athletes, and providing good energy to the team while they are on the competition floor.

The Half Season Program teams will compete at three local events from January - April.

Most typically, half season program teams compete in the "Prep" divisions at USASF sanctioned, Varsity events. The determination of the exact divisions in which teams will compete is at the sole discretion of the coaches and staff at UA and is subject to change after team placements are finalized.



FINANCIALS

We understand the significant financial commitment it is to participate in all star cheerleading. As a result, we vow to be transparent in the costs associated with the Ultimate Athletics Program as well as fair and competitive in our pricing. Full monthly tuition is \$300. It includes competition fees, registration fees, coaches' fees including competition per diems, and facility usage. The total of these estimated fees is divided into equal monthly payments, thus tuition is both pro-rated and bundled. Please note that tuition refunds are not given under any circumstances.

This monthly tuition amount does NOT include the required uniform/bow fee and the music/choreo fee assessed before the first competition. These fees are also non-refundable.

Athlete accounts must be in good standing in order to attend and compete at events with UA.

ADDITIONAL FEE CONSIDERATIONS

There is a required \$49 USASF membership fee. USASF is the governing body for all star cheer.

Athletes are expected to have white cheerleading shoes for practice and competitions. If athletes are in need of new shoes, we suggest Nfinity or Varsity brands. Once teams are solidified, our Nfinity rep will come to the gym for complimentary sizing and ordering assistance should you wish to purchase Nfinity for new shoes.

Half season athletes may opt to purchase a UA backpack. This optional ordering can also be done through the Nfinity rep.

Some teams choose to do competition goody bags and "swag bags" before competition weekends in which families contribute a small monetary donation and/or goody. Participation in goody bags is entirely optional.

BOOSTER CLUB

We have partnered with a booster club who offers several opportunities to fundraise for half season tuition. That information is provided to families upon acceptance of team placement.

SPIRIT WEAR GUIDELINES

The gym will host occasional pop-up shops for athletes and families to purchase optional spirit wear items. Only this vendor has permission to reproduce, make, and offer for purchase the use of the "Ultimate Athletics" name, UA logo, and the UA Crown.

In any event, if you or your child is injured, medical assistance may be required which you must pay for yourself.
- 2. I expressly agree and promise to accept and assume all of the risks, known and unknown, connected with Ultimate Athletics and related activities, including but not limited to performance of stunts and use of equipment. My participation and that of my child is purely voluntary. No one has forced or coerced me or my child to participate. I elect for myself and my children to participate in such activities in spite of the risks.
- 3. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Ultimate Athletics from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with my child's participation in Ultimate Athletics and related activities, practices, classes, clinics, and/or competitions.
- 4. Should Ultimate Athletics be required to incur attorney or legal fees and costs to enforce this agreement, I agree to indemnify and reimburse them for such fees and costs.
- 5. I certify that my child has health, accident and liability insurance to cover bodily injury or property damage that may be caused or suffered while participating in this event or activity, or else I agree to bear the costs of such injury or damage to my child. I further certify that I am willing to assume and bear the costs of all risks that may arise or be created, directly or indirectly, through or by any such condition.
- 6. In the event that I file a lawsuit against Ultimate Athletics, I agree to do so solely in the State of Illinois and I further agree that the substantive and procedural laws in that state shall apply in any such action without regard to the conflict of laws rules thereof. I agree that if any portion of this agreement is found void or unenforceable, the remaining portions shall remain in full force and effect.
