TRYOUT PROCESS

Tryouts criteria consists of tumbling skills and technique, stunting expertise, advanced jump skills, previous experience, and coachability.

TRYOUTS

Athletes are only required to attend one of the tryouts dates. They are to arrive promptly at 7pm, in black on black attire, hair up in a pony tail with a bow (if applicable), with gym/cheer shoes, and a water bottle. Athletes must turn in their reviewed, signed, and completed tryout packet at this time. Tryouts are closed to spectators. If an athlete cannot attend one of the tryout dates, they may email info@ultimateathletics.org and schedule a private evaluation.

CALLBACKS

Athletes will receive an email, inviting them to level callbacks. This is a preliminary level placement as we utilize the callback session to further evaluate athletes and begin to put teams together. Please note that these level placements are subject to change.

PLACEMENTS

Athletes will receive an email with their team placement and specific team details, including practice days, coach info, etc. Once athletes receive their team placement, they may accept or decline their placement. We do not discuss athletes' placements with families. The quick timeline of the quarter season program requires our full attention on the building of these teams. We will, however, provide feedback in the placement email. Please note the following:

ALL ATHLETES.

TEAM SHIFTS MAY OCCUR EVEN AFTER TEAM PLACEMENTS. AT TIMES, TEAM SHIFTS ARE NECESSARY AND IN THE BEST INTEREST OF BOTH ATHLETE AND TEAM.

THE DIVISION AND LEVEL IN WHICH EACH TEAM COMPETES IS ALSO SUBJECT TO CHANGE BASED ON THE SPEED IN WHICH THE TEAMS PROGRESS AND DEVELOP. WHEN MAKING THIS DETERMINATION, WE CONSIDER WHAT DIVISION IS THE MOST ADVANTAGEOUS FOR A TEAM'S COMPETITIVE SUCCESS WHILE ALSO ENSURING THE ATHLETES ARE CHALLENGED AND GROWING THEIR EXISTING SKILL SET.

EXPECTATIONS

CHARACTER CONTRIBUTION COMPETITION

Athletes and families are expected to represent the UA brand and program with the utmost of integrity, respect, and sportsmanship while associated (with the gym). This includes but is not limited to interactions on all social media platforms. Repeated failure to comply with these standards may result in dismissal from the program.

While in the gym and competitions, all persons voluntarily assume inherent risk and assume all responsibility. All persons will follow safety rules and protocols.

PRACTICES

As a general rule, teams will practice two times a week, for two hours at a time. Once in competition season, additional practices, although infrequent, may be required as needed. Practices are mandatory. Three (3) absences are permitted during the season; repeated and/or consistent absences during the half season may prohibit progression as a team, negatively impact a teams positive team dynamic, and can ultimately affect the athletes contributory role and/or placement on their team.

Examples of excused absences include: illness, family emergency, major family events, school sponsored commitment required for a grade, injury that prohibits attendance, family vacation with advanced two-week notice.

Anything not included in the aforementioned will be considered unexcused. Certainly, extenuating circumstances can be assessed on a case by case basis.

Practices two weeks prior to a competition date are exceptionally crucial; should an athlete miss a practice during this time, for any reason, it is at the coaches discretion should that athlete compete in the upcoming competition.

Missed practices, for any reason, will not be cause for refund. The expectation for practice is that athletes arrive on time, dressed appropriately, maintain a positive and productive relationship with teammates and coaches, and give 100% every time. Practices are closed to spectators; occasionally, we will host observation days in which spectators will be permitted.

MEDICAL/INJURY

Should an athlete suffer an injury or any medical condition that prohibits them from fully participating at a competition or from more than one (1) practice (i.e. having to "sit out" of a practice or any portion of a practice), a doctor's note must be presented to the coaches/staff. The doctor's note must include the diagnosis, prognosis, and a release from those restrictions must also be provided in order to return to participation.

COMPETITIONS

Competitions are mandatory. If for some reason an athlete is unable to attend a competition, we graciously ask for advanced notice when applicable to allow for proper preparation of an alternate athlete or routine adjustments. Competition fees will not be refunded should an athlete not participate for any given reason. Athletes are expected to arrive at competitions at their designated meet time, in uniform, competition hair/makeup, and fully prepared for the day. This includes proper nutrition (i.e. breakfast, lunch, or dinner depending on the designated meet time) and hydration.

Throughout the events, the expectation of those representing UA is that they reflect the sportsmanship ideals and standards set forth by the brand, coaches, and staff.

We will designate one person to record all performances as to allow the spectators/parents to be fully engaged in their team's performance, cheering for the athletes, and providing good energy to the team while they are on the competition floor.

if a paid bid is not earned, athletes are responsible for their Summit registration fee, paid directly to Varsity. This fee is typically \$485.00 but may change slightly from year to year.

Athletes are responsible for their travel and hotel accommodations for The Summit Championship. A \$100 coaches travel fee will be applied to gym accounts for the event as well and post season UA spirit wear is also required (approx. \$85).

ADDITIONAL FINANCIALS

Athletes are expected to have white cheer shoes; if they do not, we recommend Nfinity or varsity brand. we will also have an Nfinity rep come to the gym after tryout to size athletes for shoes if anyone needs to purchase/order them.

Athletes are expected to have white cheer shoes; if they do not, we recommend Nfinity or Varsity brand. Once teams are solidified, our Nfinity rep will come to the gym for complimentary sizing and ordering assistance should you wish to purchase your athlete's new shoes through Nfinity.

We will also have an Nfinity online store link for those wishing to purchase UA backpacks.

While not a requirement, it is common for teams to organize team bonds and competition "goody bags" which may also come at an additional cost.

___ Practices and classes may be canceled due to holidays, competitions, inclement weather, and/or unforeseen circumstances and that no refunds will be given as a result.

I understand should my

athlete resign from the team at any point during the season, any and all payments already made are non-refundable and non-transferable.

___ I understand that I am required to put a current debit/CC on file for account charges.

___ I understand that I am subject to a late fee charge of \$25.00/month after the 10th of the month. Athletes with past due tuition beyond the 10th of the month may not participate in practice(s) and/or competition(s) until the account is brought current and in good standing.

___ In the event that an athlete must resign from a team and/or a class, by signing this contract, I am solely responsible for tuition and/or class fees and acknowledge that all fees are non-refundable and non-transferable. I understand billing will not stop until a 30 day written notice is received and that I am responsible for all fees until notice is given.

___ Past due balances that exceed 120 days will be sent to a third party collection agency for which charges will apply, and the account holder will be solely responsible for the total amount.

___ I understand that all travel fees are non-refundable and do not hold Ultimate Athletics Anarchy responsible for any changes nor additions to travel plans associated with the competitive season.

___ I understand that my athlete's uniform WILL NOT be ordered until full payment for the uniform has been received. I also understand that my uniform is custom made and therefore cannot be canceled nor refunded once ordered through the 3rd party vendor. I understand that if my athlete chooses to resign from a team after the uniform has been purchased and ordered, no refunds will be given.

In consideration of the services provided by C3 Financial Inc. 1. I understand and acknowledge that the activities that I or my child engage in while on the premises or under the auspices of Ultimate Athletics pose known and unknown risks which could result in injury, paralysis, death, emotional distress, or damage to me, my child, to property, or to third parties. The following describes some, but not all, of those risks: Cheerleading, tumbling, and gymnastics, including performances of stunts and use of trampolines, equipment, and training apparatus, which entail certain risks that simply cannot be eliminated without jeopardizing the essential qualities of the activity. In any event, if you or your child is injured, medical assistance may be required which you must pay for yourself.
2. I expressly agree and promise to accept and assume all of the risks, known and unknown, connected with Ultimate Athletics and related activities, including but not limited to performance of stunts and use of equipment. My participation and that of my child is purely voluntary. No one has forced or coerced me or my child to participate. I elect for myself and my children to participate in such activities in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Ultimate Athletics from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with my child's participation in Ultimate Athletics and related activities, practices, classes, clinics, and/or competitions.
4. Should Ultimate Athletics be required to incur attorney or legal fees and costs to enforce this agreement, I agree to indemnify and reimburse them for such fees and costs.
5. I certify that my child has health, accident and liability insurance to cover bodily injury or property damage that may be caused or suffered while participating in this event or activity, or else I agree to bear the costs of such injury or damage to my child. I further certify that I am willing to assume and bear the costs of all risks that may arise or be created, directly or indirectly, through or by any such condition.
6. In the event that I file a lawsuit against Ultimate Athletics, I agree to do so solely in the State of Illinois and I further agree that the substantive and procedural laws in that state shall apply in any such action without regard to the conflict of laws rules thereof.
