

I. Check in Time is after 4:00 pm and check out time is 11:00 am. If early check-in or late check-out is needed, please contact us to see if available.

2. This is a **NON-SMOKING** and **NO PETS** home! (Automatic loss of security deposit and additional penalty for any damage).

3. We will not rent to vacationing students or singles under 25 years of age unless accompanied by an adult guardian or parent.

4. Damage/Security Deposit: A damage/security deposit of \$750 is required. This must be received with the first payment. The deposit is not applied toward rent; however, it is fully refundable within 10 days of departure, provided the following provisions are met.

- a. No damage is done to unit or its contents, beyond normal wear and tear.
- b. No charges are incurred due to contraband, pets or collection of rents or services rendered during stay.
- c. All keys are left on the kitchen table and unit is left locked.
- d. All charges accrued during the stay are paid prior to departure.
- e. No linens are lost or damaged.
- f. Kitchen returned in a neat manner.
- g. Garbage is double bagged and put in trash cans in the basement or put to road for weekly vacationers.


5. Payment: An advance payment equal to 50% of the rental is required to reserve the home. The advance payment will be applied toward the rental fee. The advance payment is not a security deposit. The balance of the rental fee is due 90 days prior. Please make payments in the form of traveler's checks, bank money orders, cashier's checks or personal checks.

6. Cancellations: A ninety (90) day notice is required for a cancellation. Cancellations that are made more than ninety (90) days prior to the arrival date will incur no penalty. Cancellations or changes that result in a shortened stay, that are made within ninety (90) days of the arrival date, forfeit the full advance payment. Cancellation or early departure does not warrant any refund of rent or deposit.

7. Maximum Occupancy: The maximum number of guests per house is limited to ten (12) persons. Insurance prohibits more than 10 occupants at anytime in the Lodge. (For comfort and safety reasons) Loss of security deposit for any parties larger than registered. The Lodge is not to be used for visiting guests, receptions or for parties other than the registered guests.

8. No Daily Maid Service: While linens and bath towels are included in the home, daily maid service is not included in the rental rate however is available at an additional rate. We do not permit towels or linens to be taken from the property. Beach towels are allowed to the lake.

9. Falsified reservation: Any reservation obtained under false pretences will be subject to forfeiture of advance payment, deposit and/or rental money and the party will not be permitted to check-in.

We will offer other available dates to compensate for unique situations.
