All Memberships Expire December 31st, All Renewals Begin January 1st

- This completed form must be returned to the Club accompanied by either your check for Membership Dues or copy of PayPal confirmation of payment. See <https://swampscottyachtclub.org> for PayPal.
- Life Members are asked to complete this form as well so we may track all returning members and note contact information updates and changes.
- This completed Annual Dues Form along with your check or PayPal confirmation is to be delivered using one of these options:
 - o (1) Drop off in the lockbox located in the bar near the pool table
 - o (2) Mail to PO Box 12, Swampscott MA 01907
- **If dues and form are received prior to January 31, 2022 you will receive \$30 in Compass Points.**
- **Returning members must have their Annual Dues received by March 1, 2022 in order to avoid a \$60 Late Fee.**
- **Any member who has not paid their annual dues by April 16th will lose all membership privileges and would be required to reapply for membership.**
- All paying members including spousal members will receive a keycard for access to the Club.
- Members are allowed in the Club at any time although bar service is only allowed when a bartender is on duty.
- All Members are expected to volunteer 10 hours of their time each year. Volunteer opportunities can take place at planned events, on one of several committees, when assistance is needed for maintenance, to name a few. Members with more than 10 years of continued membership are not required to fulfill volunteer hours.
- Upon receipt of your completed Form and Dues you will receive your 2022 Membership card and a 2022 Launch Sticker for those paying for Launch Service.
