Dr. McCullough is an internist, cardiologist, epidemiologist managing the cardiovascular complications of both the viral infection and the injuries developing after the COVID-19 vaccine in Dallas TX, USA. Since the onset of the pandemic, Dr. McCullough has been a leader in the medical response to the COVID-19 disaster and has published "Pathophysiological Basis and Rationale for Early Outpatient Treatment of SARS-CoV-2 (COVID-19) Infection" the first synthesis of sequenced multidrug treatment of ambulatory patients infected with SARS-CoV-2 in the American Journal of Medicine and subsequently updated in Reviews in Cardiovascular Medicine. He has dozens of peer-reviewed publications on the infection and has commented extensively on the medical response to the COVID-19 crisis in The Hill, America Out Loud, and on FOX NEWS Channel. On November 19, 2020, Dr. McCullough testified in the US Senate Committee on Homeland Security and Governmental Affairs, in 2021-2022 the Texas Senate Committee on Health and Human Services, Colorado General Assembly, New Hampshire Senate, Pennsylvania Senate, and South Carolina Senate concerning many aspects of the pandemic response. On January 24, 2022, Dr. McCullough co-moderated and testified in the US Senate Panel "COVID-19: A Second Opinion" chaired by Senator Ron Johnson. Dr. McCullough has reviewed thousands of reports, participated in scientific congresses, group discussions, press releases, and has been considered among the world's experts on COVID-19. His book written with best-selling true-crime author John Leake is "Courage to Face COVID-19: Preventing Hospitalization and Death while Battling the **Biopharmaceutical Complex.**"

Dr. Cindi Marsden NEVER AGAIN! How to prepare your medicine cabinet

Dr. Cindi Marsden was born just outside of Washington D.C, but she got here just as quickly as she could! Dr. Marsden received her undergraduate degree from Texas Christian University. She was a member of the women's varsity swim team and graduated Summa Cum Laude. She received her medical degree from the University of Texas Medical Branch at Galveston where she was the president of her graduating class of 1986. She completed an Ob/Gyn residency at UTMB and became board certified in 1992.

Dr Marsden has been practicing in North Texas since 1990. In 2017, she retired from hospital-based medicine and enjoyed full retirement for three years. When the Plandemic appeared in December of 2019, Dr Marsden realized the picture the media was painting was not at all what she was observing on the ground. She reached out to colleagues, data analysts and front-line workers. It was apparent that the real story was not being told. After Dr Simone Gold (American Frontline Doctors) was fired from her job as an Emergency Room physician

She applied for malpractice insurance to treat Covid on an outpatient basis, and was denied by 13 different insurance companies. Physicians could only be protected if they followed the erroneous CDC protocol, which states there is NO approved treatment outside of the hospital setting. After weeks of phone calls, emails and sharing stories of needless deaths, she managed to find a small, patriotic and faith-based company that agreed to provide malpractice insurance for 1 year.

She immediately began treating patients via telemedicine and it quickly became a very busy full-time job. She continues to provide medical treatment, at no cost, for anyone who has been told "there is nothing we can do". She continues to boldly educate the public and provide resources so that people have uncensored information

to make informed decisions. Dr Marsden's goal is to give people hope and confidence to take care of themselves and their families when our medical system refuses to deviate from the political narrative. There is no one absolute right way to treat this virus, but unless we can discuss, question and entertain other options, we will continue to live in fear, distrust our public health officials and lose hope for the future of our health care system. This Coronavirus is endemic and it is up to each and every one of us to spread the truth and the hope - the media mob is a well-oiled propaganda machine, but we can do this!!

Undaunted, Edgar ran for a position on the Pearland Independent School District Board of Trustees in the 2020 election and garnered 7511 votes. During the 87th Regular Session of the Texas State Legislature, Edgar whipped the vote for HB 1252 - a bill to extend the statute of limitations for special education complaints in Texas from one year to two years. Mr. Pacheco championed the bill now known as the Edgar Pacheco Jr. Act that was signed in 2021 by the Governor of Gregg Abbott and became law September 1, 2022.



Jill Glover SREC Women District 12 Tackling Our Legislative Priorities

Jill is the State Republican Executive Committeewoman for SD 12 and chair of the SREC Legislative Priorities Committee. She authors the Republican Party of Texas email, the Legislative Priorities Report. She tours with Grassroots of America, "Conservative Mamas," speaking on ways children are being targeted in culture and the educational system. She served on the 2020 state Republican Platform Committee, is a precinct chair and election judge, serves as a board member of the Flower Mound Area Republican Club and served as the chair of the Denton County Conservative Coalition vetting committee.

She has a master's degree in psychology, is a Licensed Professional Counselor, and has testified on a variety of bills before our state legislature. Ashley Thomas A Personal Story of Crimes Against Humanity

Ashley Smith Thomas is the Founder of Freedom's Fund USA, a nonprofit to protect freedom and national security. She is a current employee of the United States Senate and an Academy Fellow at The Heritage Foundation. Ashley is a former Political Strategist for Fox News Radio and former host of "Freedom Talks", a podcast show designed to educate Americans on key freedom and national security issues. She serves on the Board of Directors for Park Cities Republican Women and is leading a National Security series for the Texas Federation of Republican Women. Ashley started her career as the Assistant to the Vice President of Corporate Development for The Blaze in Dallas. She made a corporate move to manage a \$14.7M project to rescue and resettle persecuted Christians and religious minorities who were targeted by ISIS in 2016. Ashley and her team rescued over 1,000 families and resettled them to host countries around the world. Ashley furthered her calling by starting her own organization to work alongside the

private and public sector to protect freedom. She works toward countering threats that impact freedom in America and abroad. She has briefed panels within the intelligence community on key National Security issues.

Ashley graduated Magna Cum Laude from Oral Roberts University, with her Bachelor's degree in Organizational Interpersonal Communication & Government. She earned her Juris Masters in International Law from Liberty University's School of Law. She also received Professional Certificates in U.S. Intelligence Analysis and Project Management from SMU.

Ashley and her husband reside in Dallas, as they continue to be a voice for freedom and protect national security.



Paul Davis Fired Up TX Lawyer Don't Mess with Texas

After graduating from The University of Texas School of Law in 2011, Paul Davis worked as an associate attorney in employment law and civil litigation for two large international law firms. In 2020, Goosehead Insurance recruited Paul to be its human resources director and associate general counsel. On January 7, 2021, Goosehead fired Paul for peacefully exercising his First Amendment right to protest outside the Capitol on January 6.

Paul then started his own law firm as the "Lawyer for Patriots" and used his employment law experience to save hundreds of individuals from losing their jobs to vaccine mandates. Paul also sued Facebook and won a restraining order to free former Texas gubernatorial candidate and BlazeTV host, Chad Prather, from "Facebook jail" in the week leading up to the election.

Paul is currently suing the McKinney, Texas school board president and police for violating the First Amendment rights of parents opposed to obscene books. He is leading a movement to file tens of thousands of lawsuits in the state of Texas against Facebook, Instagram, TikTok, and other social media platforms who have censored the viewpoints of Texans using the Texas anti-censorship law. He is also preparing to sue Pfizer under the Texas Deceptive Trade Practices Act for falsely marketing its COVID vaccines as able to prevent transmission of COVID.



Jackie Schlegel Texans for Medical Freedom Executive Director

In 2015, modeling legislation passed in California, a Texas legislator filed an oppressive vaccine mandate

bill for school-age children that would have stripped parents of their right to informed consent when choosing what vaccines their children would receive. Mother of three Jackie Schlegel quickly acted by organizing other passionate moms to make their voices heard as advocates for vaccine choice in the State legislature. Through strategic grassroots activism under Jackie's leadership, the group successfully defeated that vaccine mandate bill along with fifteen other bills filed that legislative session that would have infringed on Texans' right to informed consent, medical privacy, and vaccine choice.

Over the last six years, Jackie has become one of the state's most influential advocates for medical freedom, drawing national attention for her political accomplishments that include unseating the representative responsible for the 2015 bill that started the wave of vaccine mandate legislation in Texas.

In 2021, Jackie led the initiative to advance parental rights with a parental medical protections bill and fought to protect Texas workers through efforts to ban vaccine passports. Thanks to Jackie's endless energy and tenacity, the medical freedom community has gained respect and notoriety as it has expanded its influence into our communities and state legislature. Her unshakable determination continues to inspire Texans in the fight for informed consent, medical privacy, and vaccine freedom of choice.



Marvin B. Lowe Frisco ISD Board of Trustees

Marvin B. Lowe is the newest member of Frisco Independent School District's Board of Trustees. Marvin was elected in May of this year and is the first African American man to be elected for public office in the city of Frisco. He ran on the conservative ideas of traditional moral standards, meritocracy, equality, increased transparency and strong and denounced the far left philosophies of critical race theory, gender theory and social equity.

Originally from Los Angeles, CA, Marvin moved to Dallas in the 1990's after graduating from Grambling State University, earning a B.S. in Business Management. Marvin had a track record of successful corporate sales where he served as a Senior Account Executive for AT&T, a Sales Director for AIVIA, and a Regional Sales Manager for Citysearch.com before starting Marda Realty where he is in his third decade of serving real estate clients as the Broker/Owner of the company.
