Lawn Mower Demolition Derby Rules

Redneck Round-Up Lawn Mower Derby is being held as a spectator attraction. In the interest of safety, drivers and mechanics are subject to and must obey the following rules and regulations that are set up by the VACTE Redneck Round-Up Lawn Mower Derby Committee.

- 1. Participants must be 16 years of age or older. All 16 and 17 year olds must have a parent or guardian present and have a signed consent form.
- 2. \$25 entry fee will be added to \$500.00 purse. Two pit passes will be included with entry. (Limit 15 to the first 15 paid entries)
- 3. Any riding mower with a front mounted engine is allowed. No rear mounted engines will be permitted. 18 horsepower maximum. Electric start preferred but if you have a pull start you must be able to start it FROM YOUR SEAT. Mowers must have good brakes and forward and reverse gears at the start of the demolition derby. (No homemade frames.) **No zero turn mowers.**
- 4. All decks must be removed.
- 5. You may make a homemade exhaust, but it must point straight up.
- 6. Leg guards are mandatory and must be bolted and/or welded from rear fender to front of footrest or frame. Maximum ¼ inch.
- 7. If battery or fuel tank is in the front of the engine it must be moved to a safe location.
- 8. You may make and use a hand throttle.
- 9. Hoods must be bolted or wired down tightly.
- 10. You may use a spark plug protector. This must be mounted to the ENGINE ONLY.
- 11. A rear bumper is permitted but is not allowed to extend more than 4 inches out and it must stay in between the tires; also, no spikes, sharp edges or any protrusions allowed. (Bumper can be home made with I/H beam or sq. tubing.)
- 12. Re-gearing and changing or pulleys to increase speed is permitted and encouraged.
- 13. Any and all drive train modifications are permitted but must stay belt driven.
- 14. All mowers must use lawn mower type wheels; tractor threads and cut tires will be permitted, but no tire chains or dual wheels will be allowed. Tire must be exposed, no points or sharp metal around mower.
- 15. All head lights and any other glass and plastics must be removed before you enter the pits.
- 16. No front bumpers. You can build up the front of the frame and underneath the grill to hit with. The front of the mower must be a smooth finish for safety.
- 19. For safety, if a mower does roll over, all drivers must stop and wait until that driver is out of the mower and outside of the track.
- 20. Please put your number on each side of your mower and/or helmet so we can track the winners.
- 21. We will go over all ground rules in a mower's driver's meeting before the derby.
- 22. Mower inspection will be done by the committee. If you see something, ask questions, and learn.
- 23. Helmets are required. T-Shirt or Long Sleeve Shirt and Pants Required. No open toed shoes allowed. Gloves are optional.

- 24. No profanity or obscene gestures are allowed on the mowers.
- 25. Hits are to be the wheels, and front or rear of the mower. No Hitting by the leg/footrest area. Discretion is to be used for any hit.
- 26. No placing of feet on ground allowed except to prevent a rollover of mower.
- 27. All repairs to mowers are to be done while in the seat. No getting off mowers for repairs.
- 28. No pushing off or kicking of opponent's tires allowed. If locked up with another, rocking of the mower is the only thing allowed.
- 29. You will receive only 1 warning for all infraction of the rules with the exception of the 60 second rule below. The second time is disqualification.
- 30. You must make 1 hit every 60 seconds.
- 31. JUDGES DECISION IS FINAL!!!!!!!!

Race Day (Pre-Race)

Registration – Will be completed at the trailer located in the staging area.

<u>Identification</u> – All drivers and pit personnel must show legitimate picture identification verifying age.

Pit Pass Wrist Bands -

A maximum of 2 free pit pass wristbands per vehicle entry will be issued. If your group needs more than 3 passes, extra passes can be purchased for \$30.00 per pass.

Minimum age for entry into the pits is 16 (15-year-olds with a valid graduated instruction permit only).

No one is allowed in the pit area without a pit pass.

THE AREA BY THE ANNOUNCER'S BOOTH, ARENA, FIRE TRUCKS AND AMBULANCE WHERE CARS STAGE AND ENTER THE RACE IS NOT PART OF THE PITS AND PIT PASS AREA. DRIVERS ONLY

Inspections -

Will be conducted by a team of qualified and experienced volunteer inspectors. Please give you're your cooperation.

Decisions of the Inspectors and officials are final in all cases!

Saturday – August 19th 3:00 P.M. - 4:30 P.M.

Please bring all personal safety equipment with you for inspection.

Upon successful completion of the inspection, a white flag will be attached to the driver's pillar post. After the driver's meeting each day, vehicles will be parked in an assigned area in the pit area where they will remain until they are raced.

No alcoholic beverages allowed in the pit or inspection area at any time!

Participation Agreement, Release, and Acknowledgement of Risk

In consideration of the services of VACTE, Camp Verde Arena Association (CVAA) and Town of Camp Verde, its agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting on its behalf VACTE. I hereby agree to release and discharge VACTE, CVAA and Town of Camp Verde on behalf of myself, my children, my parents, my heirs, assigns, personal representatives, and estate, as follows:

I acknowledge that a DEMOLITION DERBY entails known and anticipated risks, which could result in physical or emotional injury, paralysis, death, or damage to myself, to my property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Furthermore, CVAA volunteers have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

I expressly agree, and promise, to accept and assume all the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless VACTE, CVAA. from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity, or my use of VACTE or CVAA equipment or facilities, including any such claims which allege negligent acts or emissions of VACTE or CVAA.

Should VACTE or CVAA, or anyone acting on its behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity or else I am willing to assume, and bear the costs of, all risks that may be created, directly or indirectly, by any such condition.

In the event I file a lawsuit against VACTE or CVAA, I agree to do so solely in the State of Arizona, and I further agree that the substantive law of that State shall apply in that action without regard to the conflict of law rules of that State. I agree that if any portion of this Agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.

BY SIGNING THIS DOCUMENT, I ACKNOWLEDGE THAT IF ANYONE IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN THIS ACTIVITY, I MAY BE FOUND BY A COURT OF LAW TO HAVE WAIVED MY RIGHT TO MAINTAIN A LAWSUIT AGAINST VACTE, CVAA OR THE TOWN OF CAMP VERDE. ON THE BASIS OF ANY CLAIM FROM WHICH I HAVE RELEASED IT HEREIN.
