# HIDDEN TALENTS DANCE CENTER

**Tuition:**

- Tuition payments are due the first week of each month. Payment received after the 10th will have a \$5 late fee added to the month’s tuition fee.
- The first tuition payment is due upon registration along with a \$30 registration fee per student (non-refundable) unless noted as a returning student (\$10 for returning students).
- All tuition payments are neither refundable nor transferable. There are no refunds or deductions due to absences.
- All returned checks will be charged a \$25 returned check fee. Accounts showing two returned checks will be asked to pay remaining tuition in cash.

**Costumes:**

- Costume payment is due with your November tuition. We cannot order costumes for any student without payment in full. Late costume orders will be charged a \$20 single order fee. Once your costume is ordered, it cannot be cancelled. You must pay the balance in order to receive your costume.

**Attendance:**

- Regular attendance is essential for a student’s progress. Make up classes are allowed but please try not to be absent or late to class.
- Students or their guardians must call the studio when not attending class.
- Snow and extreme emergency cancellations will be posted on our website/facebook page. You can also call the studio to listen to the recorded message. Cancelled classes can be made up. No refunds will be issued.

**Miscellaneous:**

- All students must show up to class in dress code.
- We are not responsible for injuries sustained while on the studio premises. If you have a pre-existing condition, you cannot participate in class without a doctor’s note.
- PLEASE DO NOT DOUBLE PARK. For the safety of our students please do not double park on Hillside Avenue.

\_\_\_ **Annually** – One payment at time of registration. (10% discount with this plan) Non-refundable after 12/1/20. Dropped classes before 12/1 forfeit discount and will be charged at full price.

\_\_\_ **Semi-Annually** – First payment due at time of registration. Second payment due Feb. 1 (7% discount with this plan) Non-refundable after 12/1/19. Dropped classes before 12/1 forfeit discount and will be charged at full price.

\_\_\_ **3 Months** – First Payment due at registration. Second payment due December 1.. Last payment includes 4 months (March, April, May and June) is due March 1. (5% discount with this plan)

\_\_\_ **Monthly** – First payment due at registration. All monthly payments are due by the 10<sup>th</sup> of the month.

\*A \$5 late fee will be charged to the account for any payment received after the 10<sup>th</sup> of the due period.\* At any time you would like to participate in another form of payment plan please discuss with Miss Jess.
