

Rules and Regulations

1. This tournament is a non-sanctioned event.
2. This tournament shall be open to all bowlers with an average of 90% of 205.
3. This tournament will be held at the **Santa Fe Bowling Center, 4949 N. Rancho Blvd., Las Vegas, NV 89130 on Sunday, June 6, 2021 at 10:00am with a check-in time of 8:00am.**
4. The teams shall consist of four (4) bowlers, all men, all women, or mixed.
5. Entry blanks must be filled out in detail. First full name, initials and last name of all entrants must appear on the entry blanks. Team line-up shall appear in the proper order so that score sheets can be prepared in advance.
6. No refunds of entry fee will be made after May 26, 2021.
 - a. Must submit standing sheet along with entry form & fee.
7. Prize fund will be returned 100%. All prizes will be awarded, based on actual scores plus handicap. Prizes will be paid out following results.
8. ENTERING AVERAGES for this tournament shall be determined as follows:
 - a. Highest 2020-2021 book average, if none
 - b. Highest 2019-2020 book average, if none
 - c. Highest current average of 21 games or more. Cut-off date May 26, 2021.
 - d. Any bowler whose average is not in either of the books above and cannot be checked, must bring a bowling league standing sheet for a date up to May 26, 2021 to verify his or her entry average or enter at scratch average.
 - e. Scratch average is 190 for men and 170 for women.
 - f. USBC Rules #319a, ITEM 2, #319d and #319e are hereby waived.
 - g. No current or professional bowlers, men or women allowed.
 - h. All Sport Shot averages is subject to re-rate.
9. Handicap is based on 90% the difference of 205. Maximum handicap allowed for women is 75 pins and 50 pins for men.
10. It shall be each bowler's responsibility to determine that the submitted average is correct whether submitted by the bowler, team captain or other. If the submitted information is incorrect the team will be forfeited, and entry fee will not be refunded.
11. Substitutes for original entrants may be made, providing substitution meet eligibility requirements.
12. If a line-up is to be changed, the team captain must report the new line-up at least one and a half hours prior to bowling. New bowler shall bowl in the same position of original entrant.
13. A tardy bowler shall not be credited for any frames not bowled.
14. If you do not have an established average, you are ineligible for handicap side pots.
15. Any employee of the bowling center will not be eligible to participate.
16. All averages must be verified by the team captain. If any bowler is found ineligible the team will be disqualified and entry fee will not be refunded.
17. Entries will close on May 26, 2021. All mailed entries must be postmarked no later than May 26, 2021 AND payment made via Venmo.
