PROPOSED PUBLIC MEETING AGENDA

At the meeting, the Commissioners will discuss, take comments, and consider a vote on whether to support traffic safety improvements proposed by the DC Department of Transportation:

1. NOI 24-163-TESD Proposing to change the 2-directional Y intersection at Porter and 38th Street NW to a one-directional roundabout with crosswalks on all three approaches and parking set back 25 feet from each crosswalk, requiring removal of 19 total parking spaces on Porter and 38th Street NW. 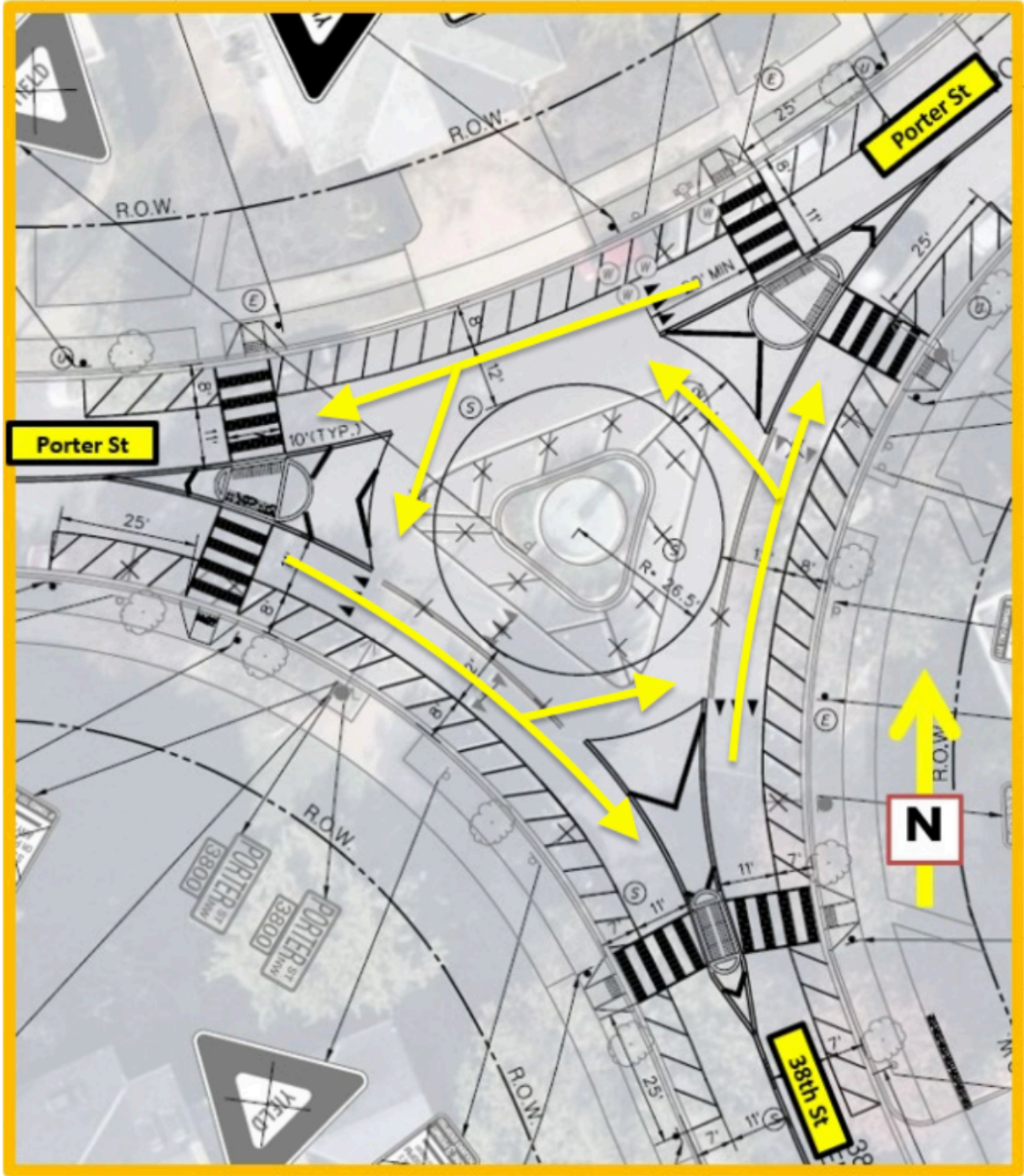
