## **MPD Community Report**

Presentation on the Mayor's Proposed Budget for FY2026 now under review in the DC Council The speaker will be Jonathan Rogers, recently appointed by the Mayor to direct the DC Department of For-Hire Vehicles and formerly with the DC Department of Transportation including as head of its "Vision Zero" program. He will speak on elements in the budget and also take questions from meeting participants.

Application for Medical Cannabis Retailer at 3715 Macomb Street to add Safe Use Treatment Facility Brittney General will present the application that Top Level LLC (doing business as "Aligned") submitted to the DC Alcoholic Beverage and Cannabis Administration (ABCA) for a Substantial Change to its 2024 license to operate as a Medical Cannabis Retailer (ABCA-127009). The shop on the second floor above Two Amys is requesting an endorsement for a "Safe Use Treatment Facility" which would offer on-site consumption of edible medical cannabis products. Hours would be the same as for retail sales. ANC 3A plans to vote at the meeting on an official position to file with ABCA on the request. Public comments are invited to anc3a@anc.dc.gov Protests or petitions to appear at the ABCA hearing on the application must be submitted to ABCA at abcalegal@dc.gov on or before June 23, 2025. ABCA's Roll Call Hearing on the application is scheduled for July 14. The Protest Hearing is scheduled for August 13.

DC Water Notice on Planned Assessment of Sanitary Sewer Infrastructure in Glover Archbold Park Representatives of DC Water will make a brief presentation on plans for DC Water's contractors to conduct field investigations, surveys, and routine inspections of the sanitary sewer and "manholes" in Glover Archbold Park through March 2026, in order to help identify existing site conditions and environmental resources to support analyses, permitting, and design for future maintenance-related activities for the sanitary sewer system in this area. DC Water will also take questions from meeting participants.

# **Commissioner Updates**

- DC Water Boil Water Advisory affecting portions of ANC 3A on June 12-13. A power outage June 12 at a pumping station caused low water pressure and required testing for possible contamination. No contaminants were found in the water and the Boil Water Advisory was lifted the next day, with instructions for affected residences to run tap water for 10 minutes and discard any water or ice from the time of the advisory.
- <u>Pepco Power Outage June 12-14 at Berkshire-Greenbriar</u>: A power line was severed during roadwork at Ward Circle. Pepco brought in generators to serve the buildings but they could not maintain continuous electric service during the repairs. Commissioners will share background and take questions and comments.
- <u>Proposed Text Amendment on Zoning for Alley Lots (ZC #25-06)</u>: The DC Zoning Commission has voted to open a formal case on Office of Planning (OP) proposal to adjust zoning regulations for alley lots. - Proposed Text Amendment on Zoning for RA-1 Zone (ZC #25-08): On June 12, the DC Zoning Commission voted to open a formal case on OP's proposed changes to zoning regulations for the RA-1 zone, primarily removing the Special Exception requirement for row homes, flats, and apartments up to 4 units, consistent with the intent of that residential apartment zone. - Update on Metrobus Stop on Wisconsin Avenue at Porter Street: WMATA Board member for DC Tracey Hadden Loh has shared WMATA and DDOT's most recent review of concerns expressed by ANC 3A and nearby residents on the relocation of the bus stop from south of Porter Street next to the Washington Ballet to north of Porter Street in front of the Crestview Condominiums.
- Better Bus Network: WMATA will be launching its system-wide reconfiguration of Metrobus routes. numbers, route maps and schedules for all Metrobus services starting June 29 as part of the "Better Bus" redesign approved by the WMATA Board in November 2024. This will include changes to the Metrobus routes serving Wisconsin Avenue, Massachusetts Avenue, Nebraska Avenue, Cathedral Avenue, Woodley Road, Porter Street and other local corridors. - DC Department of Aging and Community Living (DACL) Feasibility Study to explore potential locations for new Senior Wellness Centers in Ward 2 and Ward 3. DACL invites public participation in a survey on possible sites for programs that support seniors' wellness, connection, and independence.


