MPD Community Report

Presentation by St. Albans School about request to increase maximum faculty and staff

Representatives of the school will speak about their application to the DC Board of Zoning Adjustment (BZA Case 19606A) for a Modification of Significance to BZA Order No. 19606 in order to increase the school's maximum permitted full-time equivalent faculty and staff from 145 to 160. The application notes that the number of people who would be working on the campus would not change significantly, but some who have been working in a different status would become full-time employees.

Presentation on public space application for proposed project at 3605 Norton Place NW

As part of a new landscaping plan at the residence, the applicant proposes to add a retaining wall at the base of the driveway in public space, widen the driveway and replace previous driveway materials with permeable pavement. A public space permit from DDOT is required for those elements proposed in public space. Comments are due September 20 to DDOT under Tracking #453387. The overall plan was the subject of a presentation to ANC 3A at its January 2024 public meeting and the owner committed to return to the ANC when she submitted a public space application, which is the only part of the project that is subject to ANC review, under official DDOT public space regulations and design guidelines.
