Approve Agenda

Discussion and vote on 3 cases sent to ANC 3A by official notice since previous public meeting:

1. DDOT NOI 24-163-TESD to change the two-directional Y intersection at Porter Street and 38th Street NW to a one-directional roundabout with crosswalks on all three approaches and parking set back 25 feet from each crosswalk, requiring removal of 19 total parking spaces on Porter and 38th. Updated diagrams of the proposal were provided in advance and circulated with the proposed agenda. 2. DDOT NOI 24-179-TESD to reduce the posted speed limit from 30 mph to 25 mph on Massachusetts Avenue NW from 34th Street NW to Westmoreland Circle (DC-Maryland border). Comments are due to DDOT by 5 pm on August 29, 2024, addressed to Kelly Jeong-Olson kelly.jeong-olson1@dc.gov and should include the NOI number. Comments on both NOIs can also be submitted in writing to DDOT, Project Delivery Administration, 250 M Street SE, Washington, DC 20003. Written comments must arrive to DDOT by the due date.

3. DC Water Request for Support for Nighttime Work Permit for Sewer Rehabilitation Project (SLRP) on Wisconsin Avenue between approximately Upton Street NW and Warren Street NW. DDOT recommended that some of the work be done overnight. Expected dates for the work extend from July 2024 through July 2025. DC Water asked for ANC support for DDOT to grant the nighttime permit.

Because this is a special meeting, comments will not be taken about topics not on the agenda.

The next regular ANC 3A public meeting will be Tuesday, September 17.
