## **MPD Community Report**

CANCELED Presentation on Mayor's Proposed Budget Fiscal Year 2025 (Oct. 1, 2024-Sept. 30, 2025) Sam Abed, Director of the DC Department of Youth Rehabilitation Services, was scheduled to represent the Mayor on the highlights of the proposed District budget and take questions, but he was unable to attend. The DC Council is in the final steps of reviewing the budget, with an all-day budget work session scheduled on May 15, the first budget vote on May 29, the second budget vote on June 12, and the second vote on the Budget Support Act (which includes all the legislative changes necessitated by the dollars-and-cents budget) later in the month following the Council's second vote on the budget. The discussion with the ANC was expected to cover proposed spending in key areas of interest in the community, such as education, transportation, public safety, housing, social programs, energy and climate change, with a focus

on where enhancements or reductions are proposed.

New Executive Director Noah Getz will speak about the work of Tenleytown Main Street (TMS), which serves the commercial area along Wisconsin Avenue from Rodman Street in ANC 3A north to Fessenden Street in ANC 3E. TMS is a community-based non-profit organization that works with residents and local businesses to strengthen the economic vitality of Tenleytown and to achieve a thriving, friendly walkable business district in the heart of the neighborhood. It is supported partly by District funds and partly by private donations. TMS is one of 26 Main Street programs in the District, accredited by Main Street America<sup>TM</sup>. #### Notices of new zoning and liquor license applications in ANC3A and due dates for public comment

- <u>Lidl grocery opening soon at Upton Place, 4000 Wisconsin Avenue NW is applying for a Retailer Class "A" 25%</u> License to sell beer, wine and spirits accounting for no more than 25% of the establishment's annual revenues (ABRA-127167). Petitions and/or requests to appear at a hearing before the ABC Board must be filed electronically to <u>abra.legal@dc.gov</u> on or before June 24, 2024. The applicant will participate in the ANC 3A public meeting on June 18 to make a presentation and answer questions.
- The ANC has received notice of an <u>application for a zoning Special Exception for a two-story rear addition at 4117 38<sup>th</sup> Street NW (BZA Case 21162) with a basement at an existing two-story semi-detached home (also with a basement) in the R-2 zone in ANC3A03. The structure is a single-family home and principal dwelling of owners David Steadman and Daphne Kiplinger. The addition and proposed rear deck would extend to within 3.5 feet of the existing accessory building (a garage on the rear alley). The applicants are requesting a Special Exception from the 20-foot rear yard requirement</u>

measured from the principal dwelling to an accessory building, under DC Municipal Regulations Subtitle D § 5004.1(a), D § 5201.1, and X § 901.2. The ANC is planning to hear a presentation of the project by the applicants at the ANC 3A public meeting on June 18. The applicants have asked for an Expedited Review, which means that the DC Board of Zoning Adjustment (BZA) will consider the application at a BZA meeting but the case will not be subject to a full hearing or testimony from witnesses. Up the BZA meeting date on July 3, 2024, public comments will be accepted on the case, which can be submitted to <a href="mailto:bzasubmissions@dc.gov">bzasubmissions@dc.gov</a> for the BZA to review to determine if any additional evidence should be heard. Each submission should contain the name, mailing address, telephone number, and e-mail address of the person filing it, as well as the case number and address or name of the applicants, and nature of the comments (for example, "Comments in Support," "Comments in Opposition," or "General Comments"). ### **Commissioner Updates**

Updates will include:

- WMATA FY2025 budget approved by the WMATA Board in April, using added funds expected from DC, Maryland, and Virginia, fare increases, and cost savings to avert most of the severe reductions in Metrobus and Metrorail service that were proposed in December 2023.
- WMATA revised version of proposed 2025 Bus Network map as part of the Better Bus Initiative, issued on May 7 for public comment May 13-July 15. The proposal includes renaming and reconfiguring all current Metrobus routes.
