Resolution Recognizing the Service of Commissioner Jeremy Del Moral

As Advisory Neighborhood Commission 3A comes to the end of the first two-year term since it was established in the Ward and ANC redistricting of 2022, the Commissioners who continue to serve would like to recognize the service of colleague Jeremy Del Moral who is completing his service to the District as an Advisory Neighborhood Commissioner on December 31, 2024.

Commissioner Del Moral moved to Washington, DC, from his home state of California in 2003, and received a Master's in Business Administration from Georgetown University. He has been a resident of the Greenbriar Condominium since 2010, where he served as Treasurer of the condominium board. In 2019 was elected to fill the vacant seat as Commissioner in ANC 3D10, representing the residents of the Berkshire-Greenbriar and the entire neighborhood bounded by Massachusetts Avenue, Nebraska Avenue and Van Ness Street, including the Katzen Arts Center and. He was re-elected as Commissioner in the 2020 General Election. In 2022, he ran to serve the new ANC as Commissioner in a district covering most of the former ANCD10 but reaching south to serve Westover, north to Tenley Circle and the triangular block east to Wisconsin Avenue.

Throughout his time as Commissioner, he has been devoted to enhancing the relationship between the community and American University, including maintaining open dialogue about students living in the neighborhood. For ANC 3D and now as the designated representative for ANC 3A, he has been an important part of the AU Neighborhood Partnership, keeping up with the activities of the university and working to hear and serve the interests of residents and students who share the neighborhood and want to enjoy it.

He also has particularly worked to bring awareness to safety issues related to transportation, specifically safety for pedestrians and those using bicycles, scooters, skateboards, and other "micro-mobility" devices. In addition, his expertise on finances and markets has been invaluable in ANC deliberations on numerous issues.

For ANC 3A, he has also served throughout the past two years as Treasurer of the Commission, launching the first bank account and checkbook and building on his experience to manage the funds and ensure that the ANC remained in compliance with all financial regulations and followed all the requirements for expenditures, checks, reimbursements, and monthly and quarterly financial reports. The work of ANC 3A for this important initial term in office would not have been possible without his service.

By this resolution, the Commissioners extend thanks on behalf of the entire ANC and constituents for his service and best wishes to him and his family for the future in their new community.
