Community Announcements by Phil Thomas, new director of Mayor’s Office of Community Relations and services (MOCRS)

Presentation of plans for new restaurant Shinwa Izakaya with summer garden at 11 Ridge Square

The restaurant has received approval for a liquor license for the restaurant to open at City Ridge, with outdoor service in a “summer garden,” and has submitted plans for the patio, which it will share.

Presentation by Go Vocal about Citizen Engagement Technology to Support Outreach and Dialogue

Go Vocal is the name of software that has been developed to allow public officials and organizations to engage with constituents through surveys, informational presentations, online brainstorming and workshops, as well as in-person outreach. Formerly known as “Citizen Lab,” the company has been offering the technology and support services for over a decade in Europe and the United States. After meeting with Councilmember Frumin and multiple ANC Commissioners, Go Vocal is now offering ANCs an economical option if several contract for the service for the year and can share training.

DC Water Presentation on Program to Replace Lead Water Pipes at No Cost to DC Residences

Sean Moore, Communications Manager for Lead-Free DC, will speak about DC Water’s initiative to verify and replace 42,000 lead and galvanized iron water service lines across the District. Under this initiative, service line replacement (from the water main in the street to the home) will be free. DC Water hopes to work with entire blocks at one time where multiple homes still have lead water pipes.

DDOT Draft Permanent Guidelines for Continuing Use of Public Space for “Streateries”

DDOT has developed draft guidelines for a long-term program to allow use of public space such as sidewalks or curb lane of roadways to expand the space available for restaurants and other establishments to serve customers. DDOT developed a temporary program for streateries during the COVID-19 emergency but most of these permits are expiring at the end of 2024. DDOT hopes to present the new draft guidelines to the Public Space Committee at a public hearing on November 14. The ANC is inviting public comments, including from local establishments that are participating or would like to use streateries in the future.
