Dear Meadows at World Golf Village Residents,

We are writing to inform you about two significant rezoning proposals near our community that require your immediate attention.

A community planning meeting has been scheduled to discuss the latest proposal:

Date: January 13, 2025 Time: 6:00 PM Location: Pacetti Bay Middle School 245 Meadowlark Lane, St. Augustine

The first proposal (PUD-2024-03) at 3710 Pacetti Road seeks to rezone Open Rural (OR) land for a 60,000-square-foot commercial development with a 125-space parking lot.

The second proposal (REZ 2024-18) at 3740 Pacetti Road (adjacent property) seeks to rezone 18.5 acres to allow for 52 townhomes, including 16 workforce housing units, instead of the currently permitted 21 single-family homes. These townhomes would feature small footprints on multiple floors with private outside entrances.

These proposals are significant to our community for several reasons:

- Both represent substantial changes in land use and density
- The combined commercial development and higher-density residential would significantly increase traffic along Pacetti Road and at our Meadowlark Lane intersection
- Both requests are being handled by the same engineering firm and planning team
- These rezoning requests could influence future development proposals in our area

* First Property (see our FB post of Sept 10 2024):

3710 Pacetti Road - Requesting rezoning of Open Rural (OR) for a 60,000-square-foot commercial development with 125-space parking lot (PUD-2024-03).

* New Proposal:

3740 Pacetti Road (adjacent property) - Proposal REZ 2024-18 seeks to rezone 18.5 acres from 21 single-family homes to 52 townhomes, including 16 workforce housing units. For clarity, townhomes typically feature a small footprint on multiple floors with private outside entrances, unlike apartments which are single-level units accessed through interior hallways or exterior walkways.

Why This Matters to Our Community:

 The combination of commercial development and higher-density residential would substantially increase traffic along Pacetti Road and at our Meadowlark Lane intersection
