Dear Meadows at World Golf Village Homeowner:

At the Board of Directors meeting on November 6, 2025, the 2026 budget and annual assessment were approved for *The Meadows at Saint Johns Owners Association, Inc. dba The Meadows at World Golf Village*.

The annual assessment for 2026 will be **\$320 per home**, reflecting a \$15 increase from 2025. This adjustment is necessary to cover rising costs in:

Enter your chosen password, then enter it again to confirm and click on submit at the bottom of the page. If you own more than one unit, you can register an additional account using the same login. Click on My Profile and then click on Register an Additional Property. You will be able to use the same login for all your properties.

Click on Pay Assessments and choose One-Time Payment e-Check or Credit Card or Recurring Payment e-Check or Credit Card. **If paying by Debit or Credit Card, a convenience fee of 3.25% of the amount paid is added by the third-party vendor. If paying by e-check, there is a one-time payment processing fee of \$2.99 and a processing charge of \$1.99 for each recurring check charged by the third-party vendor.
