

A Quick Reminder of the Village Ordinance on Snow Removal

Sec. 30-7. Snow and ice removal.

(a) Responsibility of owner, occupant, etc. With the exception of lots zoned B-1 central business district, the owner or occupant of any lot or land, within the village, abutting upon any public street along the line of which a sidewalk shall have been constructed, shall, whenever the sidewalk shall be encumbered with snow or ice, clear the same from the sidewalk within 24 hours after the cessation of each storm. For lots zoned B-1 central business district, if four inches or more of snow or ice encumber the sidewalk, it shall be the duty of the public works department to clear the sidewalks within 24 hours of the cessation of each storm: when less than four inches of snow or ice encumber the sidewalk, owner or occupants of lots zoned B-1 central business district shall be subject to all provisions of this section. In case it is impossible or impractical to remove the ice from the sidewalk, it shall be treated with sand, salt or some other substance, until removed, so that the sidewalk will not be slippery or dangerous to pedestrians. In case of the failure of any owner or occupant to remove the ice from the sidewalk, it shall be the duty of the public work department to do so, and the expense of the removal or treatment shall be invoiced to the property. If the invoice is not paid within 30 days, the invoice shall become a special tax or charge against the property to be collected in the manner specified. The village administrator-clerk-treasurer shall keep an accurate account of the expenses of clearing ice and snow from each lot or parcel land. The administratorclerk-treasurer shall annually enter unpaid invoices in the tax roll as a special charge against each lot or parcel of land found in violation of this chapter, and the expense shall be collected in all respects like other general property taxes upon real estate. The amount to be charged for snow and ice removal or treatment shall be set from time to time by resolution of the village board.

(b) Deposit in street restricted. No person shall cause snow from his premises to be deposited onto the abutting sidewalk or onto any street in the village without a permit from the village board, which may require payment of a fee sufficient to reimburse the village for the cost of removing any snow so deposited.

Village Committee and Board Updates

As of the Decmeber meetings

On November 16,2022 a few of us, Butch, Marge, Amanda and Dawn from the Village attended the Walworth County Economic Development Alliances annual meeting. This year it was based on "How to make the most of and make peace with a Multigenerational Team." It featured Elizabeth Oplatka as their keynote speaker. She covered so many fasinating aspects of Working Together as a Team, much more than I could cover express in this column. She discussed all of the Generations and what they have to offer, as well as what they are known for such as the Baby Boomers being precieved as AGEING OUT. The most important thing I took away from the conference was, how it is Extremely Important to Listen and take each and every generations ideas and input into consideration. We all have a different perspective on things and the solution is usually found in Everyones Input! That we can All be Involved and we All have ideas and knowledge to Share and Use!



Arntzen Corporation continues to move ahead with their construction. Although there has been no definite date set for them to be fully operational, they are making progress. With a few Building Sturctures now on the property, they are working mainly indoors on pavement & flooring. The next step, weather providing, will begin after the new year. Which will begin the process of set up for the Rail-Spur. Gilbank Construction has been preparing the site for Volkman Railroad Builders to construct the actual Spur.

Moving Forward with the Sewer Updates, they are working towards haveing completed the majority of the work necessary on the Resetting and Replacement of damaged lines. Work on the Sliplining that is necessary for the upgrade continues, and is at leat ½ completed. They will continue onto the next phase, after the New Year with sealing and man hole repairs.

Spring Elections will be on April 4,2023. There are 3 Trustee Positions and The Village President Position, that are up for Re-Election.

Keeping in line with State Requirements, the Village will be updateing our Comprehnsive Plan this year. Aproximate start date is January 3,2023 with an approximate completion of October 2023. They will be working with Village Staff, the Planning Commision, as well as Public Participation and Open Meetings, watch for updates on any meetings that will be set up. Public Input is welcome at any of the open meetings.



Vllage of Sharon Complaint Process

Information we all can use is the process to follow when we have an issue to be bring to the Villages Attention. Waiting until the monthly board meeting will more than likely not get the kind of results you may want.

The Village does act on complaints and issues, but we also need to realize that it may not have an Immediate Outcome. Some issues need to go through different Committees and some through a Legal Process, so they may take time to resolve.

The First stop should always be the Village Clerks at the Village Hall. The issue can possibly be resolved through the them. The clerks can bring the issue to the different Departments attention and possibly to an amicable solution. You may not be the only one filing a complaint, and it could possibly be an issue the Village is already working towards solving.

If not able to address within the clerk's office, the clerk will address the issue to the proper Chair Person of whichever Committee it would fall to. It then will be added to the agenda of that Committee, for discussion and possible solution. If not on the agenda, it cannot be addressed at the committee meetings. Residents are always welcome to attend the committee meetings to further discuss the issue, as well as offer a possible solution. Usually if you have a complaint, you should also have a possible solution to offer. After the issue has been discussed at the Committee Level, they try to offer an amicable solution, and then direct it to be put on the Village Boards agenda.

Now on the Board agenda, the issue is discussed at the Monthly Village Board Meeting. The issue is discussed as well as possible solutions explained. The Board then will vote on how to address the issue and proceed to the solution.
