NOTICE FOLLOWING MARCH 4, 2025 ATTORNEYS' CONFERENCE

The Town of Winfield, Lake County, Indiana ("Winfield"), respectfully submits this Notice following the March 4, 2025 Attorneys' Conference held in this Cause. In support, Winfield states as follows:

- 1. At the March 4, 2025 Attorneys' Conference, the Indiana Utility Regulatory Commission ("Commission") directed Winfield to file a notice regarding the subject of Winfield's proposed updated testimony.
- 2. If the Commission agrees with Winfield's proposal regarding the procedural schedule of this case moving forward, Winfield proposes to provide a brief update on how it would provide service to the proposed development of Intervenor, LBL Development LLC, which is located within Winfield's proposed sewer service territory.
- 3. Specifically, Winfield would propose updating the prefiled testimony of Michael P. Duffy, Jr., P.E., to reflect and memorialize the concepts and content of paragraphs 8 through 12 of Mr. Duffy's affidavit that was previously filed in this Cause on April 4, 2024. The parties have
