FOURTH AGREED MOTION TO EXTEND STAY

Petitioner, the Town of Winfield, Lake County, Indiana ("Winfield"), and pending intervenors, the City of Crown Point, Indiana ("Crown Point"), the Town of Hebron, Indiana ("Hebron"), and LBL Development, LLC ("LBL") (Crown Point, Hebron, and LBL are collectively, the "Interested Parties") (Crown Point and Hebron are the "Municipal Parties"), by their respective counsel, for their Fourth Agreed Motion to Stay, and in support, state as follows:

- 1. On August 8, 2024, Winfield and the Interested Parties filed their most recent Third Agreed Motion to Extend Stay requesting that the Indiana Utility Regulatory Commission ("Commission") continue to stay the proceedings in this Cause to and including August 20, 2024 while the Municipal Parties pursued settlement of some or all of the issues in this matter (the "Stay").
- 2. On August 14, 2024, the Commission issued a docket entry granting the third request to extend the Stay to and including to August 20, 2024.
- 3. With the time provided by the current Stay, Winfield and Crown Point have worked through the material details of a global settlement which they believe will be acceptable to the Commission and all Interested parties.

- 4. Winfield and the Interested Parties hereby request that this matter be stayed to, and including, October 14, 2024, for the purpose of providing Winfield and the Municipal Parties with additional time to finalize the written settlement agreement, obtain approval of such settlement agreement from the respective public bodies, and file the same with the Commission.
- 5. The undersigned counsel are authorized to state that counsel for the Indiana Office of the Utility Consumer Counselor has no objection to this Motion.

WHEREFORE, the Petitioner and the Interested Parties, by their respective counsel, respectfully file and request the Commission grant this Fourth Agreed Motion to Stay.
