**SECOND AGREED MOTION TO EXTEND STAY**

Petitioner, the Town of Winfield, Lake County, Indiana (“Winfield”), and pending intervenors, the City of Crown Point, Indiana (“Crown Point”), the Town of Hebron, Indiana (“Hebron”), and LBL Development, LLC (“LBL”) (Crown Point, Hebron, and LBL are collectively, the “Interested Parties”) (collectively, Crown Point and Hebron are the “Municipal Parties”), by their respective counsel, for their Second Agreed Motion to Extend Stay, state as follows:

1. On May 23, 2024, Winfield and the Interested Parties filed their most recent Agreed Motion to Extend Stay requesting that the Indiana Utility Regulatory Commission (“Commission”) stay the proceedings in this Cause for a term of thirty (30) days to, and including, June 24, 2024, while the Municipal Parties pursued settlement of some or all of the issues in this matter.
2. On May 29, 2024, the Commission issued a docket entry granting the May 23, 2024, request to extend the stay.
3. With the time provided by the Stay, Winfield and the Municipal Parties have continued to negotiate and document a settlement, which can then be presented to their respective


public bodies for review and approval.

4. Winfield and the Interested Parties hereby request that this matter be stayed for an additional term of forty-five (45) days to, and including, August 5, 2024, for the purpose of providing Winfield and the Municipal Parties with sufficient time to negotiate, prepare, and obtain approval of a written settlement agreement.

5. The undersigned have discussed this Second Agreed Motion with counsel for the Indiana Office of the Utility Consumer Counselor ("OUCC") and are authorized to represent the OUCC has no objection to this Second Agreed Motion.

WHEREFORE, Winfield and the Interested Parties, by their respective counsel, respectfully file and request the Commission grant this Second Agreed Motion to Extend Stay.


