## AGREED MOTION FOR PROCEDURAL SCHEDULE

Petitioner, the Town of Winfield, Lake County, Indiana ("Winfield" or "Town"), by counsel, respectfully submits the following agreed procedural schedule to the Indiana Utility Regulatory Commission ("Commission") for approval, and in support, Winfield states as follows:

- 1. Winfield filed its Petition with the Commission on December 13, 2023, seeking Commission approval of a regulatory ordinance establishing a service territory for Winfield's municipal sewer utility.
- 2. The Commission issued a docket entry on December 20, 2023, instructing the parties in this proceeding to submit a proposed procedural schedule by Wednesday, January 3, 2024.
- 3. Since filing its Petition, undersigned counsel has consulted with the Indiana Office of Utility Consumer Counselor ("OUCC") and both parties have agreed to the proposed procedural schedule set forth below.

OUCC and any intervenors prefile testimony and exhibits	April 2, 2024
Town files rebuttal testimony and exhibits	April 30, 2024
Evidentiary hearing before the Commission	On or about May 21, 2024
Town files proposed order	June 25, 2024

OUCC and any intervenors file proposed order	July 16, 2024
Town files reply and any cross responses to OUCC's proposed order	July 23, 2024
Commission issues order – Day 300	October 16, 2024

- 4. Winfield and the OUCC have also agreed that responses or objections to discovery served on or before April 29, 2024, shall be due within ten (10) calendar days of service and that all discovery requests received after 5:00 p.m. on a regular business day or after noon on a Friday (or the day before a state holiday) shall be deemed served the next business day.
- 5. For discovery served on or after April 30, 2024, all responses or objections shall be due within five (5) business days.

WHEREFORE, the Town of Winfield, Indiana, by counsel, respectfully requests that the Commission approve the proposed procedural schedule set forth herein, and for all other appropriate relief.
