# **AGREED MOTION TO STAY**

Petitioner, the Town of Winfield, Lake County, Indiana ("Winfield"), and pending intervenors, the City of Crown Point, Indiana ("Crown Point"), the Town of Hebron, Indiana ("Hebron"), and LBL Development, LLC ("LBL") (Crown Point, Hebron, and LBL are collectively, the "Interested Parties"), by their respective counsel, for their Agreed Motion to Stay, and in support, state as follows:

- 1. The Indiana Utility Regulatory Commission ("Commission") held an Attorneys' Conference on April 23, 2024, to discuss the outstanding issues, scheduling and prospective procedural steps for adjudicating such issues. The Commission provided some time for all Parties to confer privately.
- 2. In an effort to investigate the possibility of resolving this Cause and also Crown Point's related Cause 46035, the Petitioner and the Interested Parties agreed to stay ("Stay") all proceedings and deadlines in this Cause beginning on April 23, 2024, including all pending petitions to intervene (and any deadlines for objection thereto), Crown Point's Motion to Vacate Procedural Schedule, and Crown Point's Motion to Consolidate this Cause with Cause No. 46035, and agreed to vacate the May 21, 2024, hearing in this Cause, consistent with the Stay.

- 3. If approved, such Stay will be in effect for a term of thirty (30) days from the April 23, 2024, Attorney's Conference..
- 4. At or near, the end of the Stay, the Petitioner and the Interested Parties will submit a status report stating whether the Petitioner and the Interested Parties' have been able to reach a resolution of some or all of the issues and may request further Commission action.
- Crown Point will file a substantially similar Agreed Motion to Stay in Cause No.
  46035 initiated by Crown Point.
- 6. The undersigned counsel are authorized to state that counsel for the Indiana Office of the Utility Consumer Counselor has no objection to this Motion.

WHEREFORE, the Petitioner and the Interested Parties, by their respective counsel, respectfully files this Agreed Motion to Stay.
