You are hereby notified that on this date the Indiana Utility Regulatory Commission ("Commission") has caused the following entry to be made:

On August 27, 2025, the City of Crown Point, Indiana ("Crown Point") filed its Agreed Motion to Continue Evidentiary Hearing and Extend Procedural Schedule ("Motion"). Petitioner indicates that it contacted the other parties in this Cause and the other parties do not object to the Motion.

The Presiding Officers, having reviewed the proposed schedules, now establish the following procedural schedule in this matter:

A. <u>Issues Related to the Overlapping Territory between Winfield and Crown</u> **Point.**

1. <u>Rebuttal and Cross-Answering Prefiling Date</u>. Winfield and Crown Point shall prefile their prepared rebuttal testimony on or before September 26, 2025. The OUCC and all other Intervenors shall prefile their respective cross-answering testimony and exhibits, if any, on or before September 26, 2025. Copies of same shall be served upon all parties of record.

B. All Other Issues Related to Winfield's Regulatory Ordinance.

1. <u>Winfield's Rebuttal Prefiling Date</u>. Winfield shall prefile its rebuttal testimony on or before September 26, 2025. Copies of same shall be served upon all parties of record.

C. Remaining Procedural Requirements.

1. <u>Evidentiary Hearing</u>. The evidentiary hearing currently scheduled to commence on September 29, 2025 is continued to 10:30 a.m. on October 21, 2025, and

continues through October 22, 2025, as necessary in Room 222 of the PNC Center, 101 West Washington Street, Indianapolis, Indiana.

2. <u>Post-Hearing Filings</u>. All parties shall file their proposed order and any briefs in support thereof on or before November 19, 2025. Any party may file a reply to the post-hearing filings on or before December 19, 2025.
