**THIRD AGREED MOTION TO EXTEND STAY**

Petitioner, the Town of Winfield, Lake County, Indiana (“Winfield”), and pending intervenors, the City of Crown Point, Indiana (“Crown Point”), the Town of Hebron, Indiana (“Hebron”), and LBL Development, LLC (“LBL”) (Crown Point, Hebron, and LBL are collectively, the “Interested Parties”) (Crown Point and Hebron are the “Municipal Parties”), by their respective counsel, for their Third Agreed Motion to Stay, and in support, state as follows:

1. On June 24, 2024, Winfield and the Interested Parties filed their most recent Second Agreed Motion to Extend Stay requesting that the Indiana Utility Regulatory Commission (“Commission”) continue to stay the proceedings in this Cause for a term of thirty (45) days while the Municipal Parties pursued settlement of some or all of the issues in this matter (the “Stay”).

2. On June 27, 2024, the Commission issued a docket entry granting the parties’ second request to extend the Stay to and including to August 8, 2024.

3. With the time provided by the Stay, Winfield and the Municipal Parties have continued to negotiate a settlement, which, upon agreement, can then be presented to their respective public bodies for review and approval.


4. Winfield and the Interested Parties hereby request that this matter be stayed for an additional term of twelve (12) days to, and including, August 20, 2024, for the purpose of providing Winfield and the Municipal Parties with additional time to attempt resolution of some remaining issues.

5. To the extent the parties resolve all remaining issues during this third-extended stay period, the parties contemplate requesting a fourth and final stay period to prepare, finalize, and obtain approval of a written settlement agreement from their respective public bodies.

6. The undersigned counsel are authorized to state that counsel for the Indiana Office of the Utility Consumer Counselor has no objection to this Motion.

WHEREFORE, the Petitioner and the Interested Parties, by their respective counsel, respectfully file and request the Commission grant this Third Agreed Motion to Stay.
