# Treasury Report - Prepared by Summit Bookkeeping

Barry gave a financial summary of the HOA Balance Sheet and Income Statement/Budget and presented the budget for 2025. It was reported that we have \$3,000.00 in annual dues, and that expenses were comprised primarily of insurance policy and accounting expenses. We currently have a balance in the bank of approximately \$12,700. Holding a \$4000 deposit for home under construction at 142 Kings Court. A motion to accept the 2025 Budget was made by Bruce Sacks and seconded by Bill. The vote passed unanimously.

- At last year's meeting, Anne Perry raised the question about a non-working fire hydrant next to her property at 161 Kings Court. Fez Fairfield Smith inquired with the Buffalo Water District. Follow-up found that the hydrant was turned off temporarily for repair. It is now working properly.
- At last year's meeting, Bruce Sacks raised the question about a county truck that broke the asphalt pavement on Lakeview Drive. The County fixed the broken asphalt pavement.
