## **ANNUAL MEETING MINUTES**

## Monday, November 19, 2018 at 7:00 p.m. in the Pool Pavilion at the Association.

- 1) Meeting was called to order at 7:11 p.m. by the President as Members were still checking-in and casting ballots and the board wished to have the maximum number of Members participate; and
- 2) Establishment of Quorum:
  - a. Seventeen (17) Members were present; and
  - b. Twenty (20) Proxies were granted to Erik Shryock; and
  - c. One (1) Limited Proxy was granted to Erik Shryock; and
  - d. One (1) General Proxy was granted to Jason Dasher; and
  - e. The aggregate of these is thirty-nine (39) Members participating; and
  - f. Quorum as established in the Bylaws (Page 6, Article X, Section 4) is 30% of Members must participate.  $108 \text{ TVI x} \cdot 3 = 33 \text{ votes}$ .
  - g. The total of the Members participating is thirty-nine (39) and the Meeting proceeded; and
- 3) Proof of Notice of Meeting was provided by Matt Jelinek, CAM. Mr. Jelinek provided two (2) signed Affidavits of Mailing along with notices sent; and
- 4) The 2018 Annual Report was reviewed and explained to Members. Members were told in conjunction with a separate notice hand delivered to each door on Thursday, November 15, 2018 before 7:00 p.m., local time, that the Annual Report is available for download at MadisonHOA.com on the front page of the website; and
- 5) 2019 Budget Vote was handled as a roll call vote following a Motion by the Vice President and a second by the Treasurer to adopt the 2019 Proposed Budget. Votes resulted as follows:
  - a. Yay's including motion and second were thirty-five (35)
  - b. Nay's were one (1)
  - c. There were three (3) Members who did not vote
  - d. The motion carried and the 2019 Budget was adopted.
- 6) 2019 Board of Directors Vote was conducted. No ballots were accepted after 7:11 p.m. when the meeting was called to order concurrent with Florida Statutes; and
  - a. Treasurer verified that each envelope was sealed, signed, had the member's name and address on the outside of the envelope.
  - b. President provided second verification that each envelope was sealed, signed, had the member's name and address on the outside of the envelope.
  - c. Vice President opened each ballot setting the envelopes on one side and the ballots on another.
  - d. President and Treasurer were each provided a tally sheet as Vice President called off each ballot prior to handing the ballot to the Manager.
  - e. The tally of votes were totaled and reviewed by the Vice President and the CAM. The sheets matched and the results were as follows:

i.	Candidate Sierra Bubb	received thirty-one	(31) votes; and
ii.	Candidate Jason Dasher	received thirty	(30) votes; and
iii.	Candidate Joseph Davidson	received twenty-nine	(29) votes; and
iv.	Candidate Erik Shryock	received thirty-three	(33) votes; and
٧.	Candidate Larry Singh	received thirty	(30) votes; and
vi.	Candidate Parker Woolfolk	received three	(3) votes.

f. The 2019 Board of Directors was announced to the Members present and the 2019 Board moved into Executive Session for officer election.

- v. There were no other nominations.
- b. Each of the nominees above was elected unanimously by a voice vote with no abstentions and no Nay's.
- c. The 2019 Board of Directors included the following as *additional* agenda items for the Monday, December 17, 2018 Meeting:
  - i. Vice President request for a small budget for a Community New Year's Eve Event at the Association; and
  - ii. Board Certifications; and
  - iii. Bank change to CHASE BANK, N.A.; and
  - iv. Compliance Chair Nomination since Chairperson Dasher is now on the Board of Directors and this Committee is part of the Compliance Appeals Process; and
  - v. Members tailgating in.
- 8) MOTION TO ADJOURN was made at 8:11 p.m., local time by the Vice President and seconded by the Treasurer. No abstentions and no Nay's on a voice vote. The Motion carries and the First Annual Meeting of the Madison Place of Pompano Beach Homeowners Association, Inc. was adjourned.
