# **Our Trip Policies and Waivers**

Please carefully read and initial under each paragraph below. And please FULLY UNDERSATND that, by doing so, you are acknowledging that you understand the information presented and you agree to follow that policy.

#### Deposit and Payment

This completed application and a deposit are necessary at the time of booking. Full payment is generally due 45 to 90 days prior to departure. Bookings made within 60 days of departure are to be PAID IN FULL and may be assessed additional fees if administrative expenses are incurred. Certain more expensive trips may require a larger deposit (\$500-\$1000) and require following a multiple payment schedule.

## Trip Modification

## Substitutions, Modifications, Changes

It is further understood and agreed that the remoteness of the area, new local government regulation, customs, prevailing weather conditions, or any other factors may cause substitution of facilities and/or equipment, minor inconvenience, or modification of the travel itinerary. All agents and employees of Diver's Oasis reserve the right to modify and/or cancel diving arrangements due to unfavorable weather conditions or any other reason that may affect the safety of the group, and to substitute facilities and equipment if necessary. No refunds can be made for arrangements canceled due to adverse weather, mechanical failure, or for substitution or facilities and/or equipment, or for minor inconvenience. Unused portions of trips are nonrefundable.

## Waiver of Liability

The applicant, or the undersigned parents/guardians of the applicant under the age of maturity, understands and agrees that neither Diver's Oasis, nor PADI Americas, Inc., nor its affiliate of subsidiary corporations, nor any of their respective employees, officers, agents, contractors or assigns (hereinafter referred to as "Released Parties,") may be held liable or responsible in any way for any occurrence on this trip which may result in personal injury, property damage or wrongful death or other damages to me, my family, estate, heirs or assigns that may occur as a result of my participation in this trip or as a result of the negligence of any party, including the Released Parties, whether passive or active.

## Limits of Responsibility

It is understood that the owners and employees of Diver's Oasis assumes no responsibility or liability for service, transportation, or equipment made available by any resort, hotel, or other person or entity, either as to its availability or as to its safety, quality, or condition, nor for the acts of any employee or agent of such establishment, firm, or entity.

It is also understood and agreed that any owner or employee of Diver's Oasis does not, by acceptance of this applicant, assume any responsibility or liability for the safety of any participating individual,

particularly when such individual is engaged in underwater activities, whether alone or in groups, under the supervision of tour escort, or otherwise.

It is expressly understood that Diver's Oasis, its owners, and employees, cannot verify either the ability or suitability to scuba dive of each trip participant and therefore cannot guarantee that the participant will be allowed to dive by the dive operator. If the diving proficiency of the participant is not acceptable, a refund for the diving portion of the trip is totally at the discretion of the dive operator. Diver's Oasis will return to the trip participant any refund offered by the dive operator, less any reasonable charges or expenses incurred in securing that refund.

It is expressly understood that the tour escort of the trip is acting only in the capacity of a tour escort. Although the escort may or may not be a certified scuba instructor and will give freely of his/her diving knowledge and experience, the escort is not acting in the capacity of instructor unless specifically noted by a separate agreement.

It is expressly understood that, due to the possible remoteness of the destination, access to adequate first responder treatment, immediate medical car, and appropriate hyperbaric care facilities (recompression chambers) may be extremely limited if not totally unavailable without considerable transport. For this reason, we **VERY STRONGLY** advise all trip participants to be insured though Divers Alert Network or DiveAssure.

#### Our VERY UGLY Cancellation Policy

When a space on a trip is sold, it is removed from our trip inventory and no further attempts are made to sell that space. Some destinations require a certain group size to guarantee special services and rates. For this reason, all trip deposits are completely nonrefundable. Once the final payment is made, it too becomes 100% nonrefundable, even if the trip eventually sells out or not. If you cancel at any point, your money is forfeit, period. NO exceptions. We strongly advise our travelers to obtain trip interruption/cancellation protection programs in the event of a forced or unforeseen trip cancellation.
